### A PROCLAMATION.

IN pursuance and exercise of the powers conferred by section eleven of the Land Act, 1908, I, Robert Stout, the Administrator of the Government of the Dominion of New Zealand, do hereby, with the consents of the lessee and mortgagee of the lands described in the First Schedule hereto, and of the Wallace County Council, being the local authority in whose district the said lands are situated, proclaim as a road the lands described in the said Schedule; and also do hereby, with the like consents as aforesaid, proclaim as closed the road described in the Second Schedule hereto, which is not required.

Now, therefore, in pursuance and exercise of the power and authority conferred upon me by section twenty-five of the Reserves and other Lands Disposal and Public Bodies Empowering Act, 1911, I, Robert Stout, the Administrator of the Government of the Dominion of New Zealand, do hereby proclaim and declare the lands enumerated in the Schedule hereto to be subject to the provisions of section one hundred and twenty-seven of the Land Act, 1908; and I do further fix three years from the date mentioned in the said Schedule as the period for which the said lands shall be exempt from payment of rent. exempt from payment of rent.
