

thence south-easterly along that bank by Section 3160, Block VI, Turiwhate Survey District, again by the left bank of the last-mentioned river to a point in line with the south-western boundary of Section 2204; thence across the said river and a road reserve to that section and along its south-western boundary, a distance of 400 links; thence by a right line bearing (approximately) south 237° 00' west to the north-eastern boundary of Section 3069, Block IX, Turiwhate Survey District; thence north-westerly along that boundary to the eastern boundary of Reserve 145; thence by that reserve a distance of 4000 links; thence north-easterly along a line bearing (approximately) north 57° 00' E. a distance of 9400 links; thence north-westerly along a line bearing (approximately) north 317° 45' west to the western boundary of Block V, Turiwhate Survey District, and distant 5600 links along the said block boundary due north of the north-eastern boundary of the said Reserve 145; thence along the said western boundary and again by the said Reserve 145 to the southern corner of Scenic Reserve 914; thence north-easterly along the south-eastern boundary of the said scenic reserve and its productions to the right bank of the Kawhaka Creek; thence along that bank to a point in line with the south-eastern boundary of Section 1750, Block IV, Kanieri Survey District; thence to and by the said section and the production of its north-west boundary to and by the last-mentioned creek-bank to the south-western corner of Reserve 1065; thence by that section to the Old Christchurch Road; thence across the said road, and by Sections 1063, 1064, and 1121, Block IV aforesaid, to the north-west corner of the last-mentioned section; thence north-westerly by a right line to the intersection of Duffers Creek Road with the pipe-line reserve; thence south-easterly along the southern boundary of that reserve, by Section 1357, across the Old Christchurch Road, by Section 1355; thence along the southern side of the last-mentioned road to a point in line with the south-eastern boundary of Section 1356; thence across and by that section, across the Loopline Road, again by Section 1356, by the pipe-line reserve to the reservoir reserve; and thence northerly generally by that reserve to the point of commencement; save and except Section 3060, Block V, Turiwhate Survey District, the Okuku Reservoir Block I aforesaid, Bill's Creek Reservoir, and all roads and road reserves which are within the above-described boundary. As the same is delineated on sheet 49, roll plan 450, deposited in the Head Office, Department of Forestry, at Wellington, and thereon bordered green.

All that area of land in Blocks XIII and XIV, Turiwhate Survey District, in the Westland Land District, being Reserve 1617, containing by admeasurement 3,360 acres, more or less. Commencing at the intersection of the eastern boundary of Reserve 145 with the northern boundary of Block XIII, Turiwhate Survey District, and proceeding easterly along the northern boundary of that block and of Block XIV of the said survey district a distance of 19200 links; thence due south to the northern boundary of Reserve 961; thence westerly along that boundary to the eastern boundary of Reserve 145 aforesaid; and thence northerly along that boundary to the point of commencement: save and except therefrom Section 801, Block XIV, Turiwhate Survey District, which is within the above-described area. All that area of land in Block IV, Turiwhate Survey District, in the Westland Land District, being Reserve 1618, containing by admeasurement 740 acres. Commencing at the eastern corner of Section 3200, and proceeding along its eastern boundary to Section 2983; thence along the south-eastern and eastern boundaries of the said section, the latter produced to the left bank of the Taramakau River; thence along the said river-bank to a point in line with the north-western boundary of Section 3326; thence along the western and southern boundaries of the said section to the western boundary of Section 2973, Block VIII, Turiwhate Survey District, and along the said western boundary; thence along the southern and eastern boundaries of the said section to a road reserve, thence along the eastern side of the said road reserve to the south-western corner of Reserve 1050; thence along the southern boundary of said reserve to the western boundary of Section 2982, and along that boundary to the southern boundary of Block IV, Turiwhate Survey District; thence along the said block boundary to the south-eastern boundary of Section 3200; and thence along the said section boundary to the point of commencement. Commencing at the north-eastern corner of Section 2396, Block VIII, Turiwhate Survey District, along the northern and north-western boundaries of said section to a

point on the latter boundary 900 links from the south-western corner of said Section 2396; thence in a north-westerly direction to the western boundary of Block VIII, Turiwhate Survey District; thence by a right line to a point near the southern corner of Section 3200; thence by a right line to the north-western boundary of Section 2395, Block V, Oira Survey District, and along the said north-western boundary and the south-western boundary of said section the south-western boundary of Sections 2036, 2028, 3145; thence along the southern and eastern boundaries of said section 3145; thence along the eastern boundaries of Sections 2011, 2028, 2036; thence along the north-eastern boundary of Section 2395 to the western boundary of Block V, Oira Survey District, and along the said block boundary to the southern boundary of Section 2982, 4600 links; thence east-south-east to the south-eastern corner of Section 2007; thence due east 15700 links; thence due south, 3800 links; thence south-westerly, 31400 links; thence due south to the southern boundary of Block X, Oira Survey District; thence along the boundaries of the said Blocks X and IX, Oira Survey District, and Block XII, Turiwhate Survey District, 6200 links; thence due north, 32200 links; thence west-north-west to the southern boundary of Section 2396; and thence along the said southern boundary and the south-eastern boundary of the said section to the point of commencement. As the same is delineated on sheet 49, roll plan 450, deposited in the Head Office, Department of Forestry, at Wellington, and thereon bordered green.

All that area of land in the Westland Land District, situate in Block XI, Waimea Survey District, being Reserve 1620, containing 960 acres, more or less. Bounded as follows: Commencing at the south-eastern corner of Section 3230, and proceeding south-easterly across a road reserve; thence along the south-eastern side of the said road reserve to the Chesterfield Road; thence along the south-western side of the said Chesterfield Road for a distance of 35 chains; thence south-easterly to a point on the southern boundary of Block XI, Waimea Survey District, 80 chains from the south-eastern corner of the said block; thence due west along the said southern boundary of Block XI for a distance of 100 chains; thence due north to the south-western boundary of Section 3230; and thence along the said section boundary in a south-easterly direction to the point of commencement. Bounded as follows: Commencing at the south-eastern corner of Block XI, Waimea Survey District, and proceeding easterly along the southern boundary of Block XII, Waimea Survey District, to the Kumara-Hokitika Road; thence along the western side of the said road to the north-eastern corner of Section 1927; thence along the northern boundary of the said section produced to the left bank of the Kapitea Creek; thence by the said bank to the northern boundary of Section 1850, and by that boundary and the western boundary of said section 1850 and Sections 1771 and 1772 to the western corner of Section 1849; thence by the southerly boundary of that section, across the Kumara-Hokitika Main Road, and along the southerly boundary of Section 1852 to its south-eastern corner; thence southerly to the north-westerly corner of reservoir reserve, and along the western boundary of said reserve to pipe-line reserve, and by the northern, western, and southern boundaries of said pipe-line reserve to the western side of Duffer's Creek Road, and along the said road, 4600 links, to Fox's Creek; thence along the right bank of said creek to a point in line with the south-eastern corner of Section 3038; thence to and along the eastern and northern boundaries of the said section to a point due south from a point on the southern boundary of Block XV, Waimea Survey District, 67 chains from its south-western corner; thence due north to the aforesaid point on the southern boundary of Block XV; thence along the southern and eastern boundaries of the said Block XV to a point in line with the south-western boundary of Regulation License 202; thence to and along the southern boundary of the said regulation license and along its eastern boundary, and across the Kumara-Hokitika Main Road; thence along the northern side of the said road to the eastern boundary of Block XV, Waimea Survey District; and thence along the said block boundary to the point of commencement: save and except therefrom Sections 1358, 1359, 1364, and 1958.
