

Sections 988, 987, and 2775, the western boundary of said Section 2775, and its production to the right bank of the Styx River; thence westerly along the right bank of the said Styx River to a point in line with the eastern boundary of Section 2103, Block XV, Kanieri Survey District; thence following along the eastern and northern boundaries of Sections 2103 and 1939 to the eastern boundary of Section 1651, Block XIV, Kanieri Survey District; thence along the eastern boundary of said Section 1651 to its north-eastern corner; thence by a right line to the north-eastern corner of Section 568, Block X, Kanieri Survey District; thence along the north-eastern boundary of aforesaid Section 568 to a road-line; thence following along the eastern and northern side of said road-line to the south-eastern corner of Section 837, Block X, Kanieri Survey District; thence along the eastern boundary of said section 837, across a road reserve, and by the eastern side of said road reserve to Raft Creek; thence along the right bank of Raft Creek to the south-eastern corner of Section 1451, Block X, Kanieri Survey District; thence along the eastern boundary of said Section 1451, across Lang Road, and by the northern side of that road to the south-eastern corner of Section 2037, Block V, Kanieri Survey District; thence along the eastern and north-eastern boundaries of aforesaid Section 2037 and across a road reserve to the south-eastern boundary of Section 3151, Block VI, Kanieri Survey District; thence along the south-eastern boundary of aforesaid Section 3151, across the Kanieri River to a point on the right bank in line with the aforesaid south-eastern boundary of Section 3151; thence following along the right bank of Kanieri River to a point in line with the eastern boundary of Section 3182, Block VI, Kanieri Survey District; thence to and along the said eastern boundary to a point across the Kanieri Lake Road; thence along the northern side of said Kanieri Lake Road to the south-eastern corner of Section 3068, Block V, Kanieri Survey District; thence along the eastern and northern boundaries of said Section 3068 to a point on the right bank of Stony Creek in line with the northern boundary of aforesaid Section 3068; thence along the right bank of said Stony Creek to the southern boundary of Block II, Kanieri Survey District; thence due west to a point due south of the south-western corner of Section 3262, Block I, Kanieri Survey District; thence due north to the said south-west corner of aforesaid Section 3262, and along the southern and eastern boundaries of said Section 3262, and across a road reserve to a point in line with the eastern boundary of aforesaid Section 3262; thence by the northern side of said road reserve to a point in line with the north-western boundary of aforesaid Section 3262; thence by a right line in a north-easterly direction to a point on the Blue Spur Road where the said road intersects the western boundary of Block II, Kanieri Survey District; thence along the southern side of said road to the north-western corner of Section 3021, Block II, Kanieri Survey District, and by the western, southern, and eastern boundaries of said Section 3021 to the south-western corner of Section 1940, Block II, Kanieri Survey District; thence along the southern boundaries of Sections 1940, 1944, 1911, and 1959 to the south-eastern corner of the last-mentioned section; thence by its eastern boundary to the Upper Crossing Road, and by that road and Humphrey's Gully Road to the north-western corner of Section 1957, Block II, Kanieri Survey District; thence by the western, southern, and eastern boundaries of aforesaid Section 1957 to the south-western corner of Section 1350; thence along the southern boundary of said Section 1350, across a road reserve, and along the southern boundary of Section 1220 to the north-western corner of Reserve 279; thence by its western, southern, and eastern boundaries to the southern boundary of Section 1935; thence by the southern and eastern boundaries of said Section 1935 to the south-western corner of Section 1454; thence along its southern boundary to the south-eastern corner; thence from the said south-eastern corner of Section 1454 to the south-western corner of Section 1830, Block III, Kanieri Survey District; thence along the southern boundary of aforesaid Section 1830 and its production to a road reserve; thence along the western side of said road reserve to a point opposite the western corner of Butler's Freehold (Reserve 145); thence across the said road reserve to the said western corner of Reserve 145; thence along the south-western boundary of Butler's Freehold (Reserve 145) to the north-eastern corner of Scenic Reserve 1177, and along the northern boundary of the said reserve to the Lake Kanieri Water-race; thence along the said water-race to the eastern boundary of Block VI, Kanieri Survey District; thence along the eastern boundary of Block VI to the north-eastern corner of said block; thence along its northern boundary for a distance of 110 chains; thence due south for a distance of 90 chains; thence due east for a distance of 40 chains; thence due south to the Kanieri Lake Road; thence due east to the western boundary of Scenic Reserve 1177; and thence along the western and south-western boundaries of said Scenic Reserve 1177 to point of commencement. As the same is delineated on sheet 41, roll plan 450, deposited in the Head

Office, Department of Forestry, at Wellington, and thereon bordered green.

All that area of land in Blocks VIII and XII, Mahinapua Survey District, and Blocks V and IX, Kanieri Survey District, in the Westland Land District, being Reserve 1623, containing by admeasurement 3,500 acres, more or less. Commencing at the north-western corner of Reserve 1462, and proceeding southerly along its western boundary to the western side of Eel Creek Track, and along the said track to the northern boundary of Section 3157; thence westerly along the said northern boundary, across a road reserve, again along the said northern boundary, along the western boundary of said Section 3157, across a road reserve, and again along the said western boundary to a road reserve; thence generally westerly along the northern side of said road reserve to the south-eastern corner of Section 3344; thence northerly along the south-eastern boundary of the said section to its north-eastern corner; thence by a line bearing 65° 00' to the south-western boundary of Reserve 208; thence along the said south-western boundary and the south-eastern and north-eastern boundaries of the said Reserve 208 to the eastern side of the Ross-Hokitika Road; and thence in a north-easterly direction to point of commencement: save and except therefrom all roads and tracks within the described area. As the same is delineated on sheet 41, of roll plan 450, deposited in the Head Office, Department of Forestry, at Wellington, and thereon bordered green.

All that area of land in Block XVI, Mahinapua Survey District, in the Westland Land District, being Reserve 1625, containing by admeasurement 460 acres, more or less. Commencing at Trig. C, and proceeding along the southern boundary of Block XVI, Mahinapua Survey District, to the right bank of the Hokitika River; thence along the said bank to a point opposite the southern boundary of a reserve; and thence to the south-western corner of the said reserve, and along its southern boundary and the southern boundaries of Sections 2271, 2272, and 2277 to the eastern boundaries of Block XVI, Mahinapua Survey District, and along the said eastern boundary to the point of commencement. As the same is delineated on sheet 41, roll plan 450, deposited in the Head Office, Department of Forestry, at Wellington, and thereon bordered green.

All that area of land in Block I, Toaroha Survey District, in the Westland Land District, being Reserve 1626, containing by admeasurement 375 acres, more or less. Commencing at Trig. C, and proceeding along the northern boundary of Block I, Toaroha Survey District, the western boundary of Reserve 341; thence along the said western and the southern boundary of the said reserve to the western boundary of Section 966, then along that boundary and the western boundaries of Sections 967 and 969 produced to the Hokitika River; and thence along the right bank of the said river to the western boundary of Block I, Toaroha Survey District; thence along the said block boundary to the point of commencement. As the same is delineated on sheet 41, roll plan 450, deposited in the Head Office, Department of Forestry, at Wellington, and thereon bordered green.

All that area of land in the Westland Land District, situate in Blocks II, III, V, VI, VII, and IX, Toaroha Survey District, being Reserve 1627, containing 12,400 acres, more or less. Bounded as follows: Commencing at the most southerly corner of Section 2148, Block III, Toaroha Survey District, and proceeding along its south-eastern boundary to the left bank of the Browning or Styx River; thence along the said bank to the western boundary of Block IV, Toaroha Survey District; thence along the western boundary of the said block to its south-western corner; thence by a right line to the south-western corner of Block VI, Toaroha Survey District; thence to the mouth of Bluff Creek, continuing across the Hokitika River to its left bank; thence due south to the southern boundary of Block IX, Toaroha Survey District; thence along the said southern boundary to the south-western corner of the said Block IX; thence along the western boundary of the said Block IX to its north-western corner; thence along the northern boundary of the said block to the right bank of the Hokitika River; thence along the said bank to a point in line with the south-western boundary of Section 720; thence to the western corner of the said section, along its south-western boundary, across the Whitcombe Valley Road, and along the eastern side of the said road to a point in line with the north-eastern boundary of the said section; thence along the north-eastern boundary of the said section produced to the right bank of the Hokitika River; thence along the said bank to a point in line with the south-western boundary of Section 2322; thence along the said boundary to the southern corner of the said section; thence along the south-eastern boundary of Section 2322, across a road reserve, Diedrich's Creek, and again a road reserve, and along the southern boundary of Section 986 and across a road; thence generally in a north-easterly direction to the western corner of Section 2386, and along the south-western boundary of said section produced to the right bank of the Toaroha River; thence along the said
