WHEREAS by an Act of the General Assembly of New Zealand intituled the Prisons Act, 1908, it is pro-

vided that the Governor-General may, by Proclamation pub-Vided that the Governor-General may, by Proclamation pub-lished in the Gazette, declare any house, building, enclosure, or place to be a prison, and from and after the gazetting of any such Proclamation, or from any time later specified in the Proclamation, such house, building, enclosure, or place shall be deemed a prison: Now, therefore, I, John Rushworth, Viscount Jellicoe, Governor-General of the Dominion of New Zealand, in pur-suance of the above-recited power and authority, do hereby declare that the area of land described in the Schedule hereto, and all buildings and enclosures used or occupied thereon.
