RESOLUTION STRIKING SPECIAL RATE.—MANGERE CROSSING WATER-SUPPLY SPECIAL RATING AREA.

IN pursuance and in exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1913, and of all other powers (if any) it thereunto enabling, the Manukau County Council hereby resolves as follows:—

'That, for the purpose of providing for the payment of interest, sinking fund, and other charges on the Manukau County Council Water-supply Loan of £7,000, 1921, authorized to be raised by the Council, under the above-mentioned Act. for the purpose of supplying water to portion of the rized to be raised by the Council, under the above-mentioned Act, for the purpose of supplying water to portion of the Mangere Riding in the vicinity of the Mangere Crossing, Manukau County, the said Council hereby makes and levies a special rate of one penny and three-eighths of a penny in the pound sterling on the rateable value (on the basis of the capital value) of all rateable property in the Mangere Crossing Water Loan Special Rating Area, bounded as follows,—
All that area in the North Auckland District, situated in Blocks V, VI, IX, and X, Otahuhu Survey District, bounded, commencing at the intersection of Massey Road and the North Island Main Trunk Railway, towards the north-east by the said railway forming the south-western boundary of
