WAIKATO COUNTY COUNCIL.

*Special Order merging the Kirikiriroa Road District in the County of Waikato.*

IN pursuance of the provisions of section 31 of the Counties Act, 1908, and upon a petition of a majority of the ratepayers of the Kirikiriroa Road District possessing in the aggregate not less than half of the rateable property in such district, the Waikato County Council hereby declares the Kirikiriroa Road Board dissolved and the Kirikiriroa Road District merged in the County of Waikato, on and after the 1st day of April, 1921.
