MASTERTON COUNTY COUNCIL.

RESOLUTION MAKING SPECIAL RATE.

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1913, the Masterton County Council hereby resolves as follows:—

That, for the purpose of providing the instalments in respect of principal and interest and also the other charges on a loan of five thousand pounds, authorized to be raised by the Masterton County Council, under the Local Bodies' Loans Act, 1913, for the purpose of providing the Masterton County Council's share of the cost of constructing bridges over the Taueru River and the Rorokoko Stream at Taueru

and Rorokoko, known as the Taueru Traffic-bridge and the Rorokoko Traffic-bridge, both bridges being on the Masterton-Waimata Road, the said Masterton County Council hereby makes and levies a special rate of one thirty-sixth of a penny in the pound upon the capital rateable value of all the rateable property of the County of Masterton; and that such special rate shall be an annual-recurring rate, and payable half-yearly on the first days of February and August in each and every year during the currency of such loan, being for a period of thirty-six and one-half years, or until the loan is fully paid off.
