**T**HE following notice, received from the Mayor of the Council of the Borough of Gore, is published in accordance with the provisions of the Local Bodies' Loans Act, 1913.

**BOROUGH OF GORE.**

PURSUANT to section 12 of the Local Bodies' Loans Act, 1913, I hereby give notice that a poll of the ratepayers of the Borough of Gore was taken on the 18th day of May, 1921, on the proposal of the Gore Borough Council to raise by special loan a sum of £14,000 for the following purposes and upon the terms hereinafter stated, namely:—

Drainage-works in West Ward of the Borough of Gore	£8,000
Water-supply works in the said West Ward	£6,000

The said sums are to be raised and the repayment thereof secured by the issue of debentures bearing interest at the rate of £5 10s. per centum per annum, or such higher rate not exceeding £5 15s. per centum per annum as the Governor-General in Council may prescribe, and payable half-yearly, and with a sinking fund of £1 per centum per annum, such debentures to have a currency of twenty-one years from the date of issue. The security for the repayment of the said debentures shall be the said undertaking, and also a special rate of one penny in the pound on the whole of the rateable property in the said borough.

It is proposed to pay out of the said loans the preliminary expenses of raising the same, and the first year's interest and sinking fund payable in connection therewith.

The number of votes recorded for the proposal was 151, and the number of votes recorded against the proposal was 88; informal, 2.

I therefore declare that the proposal was carried.
