TN pursuance and exercise of the powers and authorities In pursuance and exercise of the powers and authorities conferred upon him by section thirteen of the Scenery Preservation Act, 1908 (hereinafter referred to as "the said Act"), His Excellency the Governor-General of the Dominion of New Zealand doth hereby vest the control of the scenic reserve described in the Schedule hereto (being land reserved under the said Act) in the Invercargill Borough Council,

Vesting the Control of a Scenic Reserve in the Orari Gorge Scenic Board.

JELLICOE, Governor-General.

IN pursuance and exercise of the powers and authorities conferred upon him by section thirteen of the Scenery Preservation Act, 1908, His Excellency the Governor-General of the Dominion of New Zealand doth hereby vest the control of the reserve described in the Schedule hereto (being land reserved under the said Act), for the period of three years from the date hereof (unless previously altered or revoked under the said Act), in the undermentioned persons, namely,

> ARTHUR JOHN BLAKISTON, ROBERT BORROWS, WILLIAM ALEXANDER HEWSON, WILLIAM McLEOD, and ROBERT YATES,

who are hereby constituted for that purpose a special Board by the name of the Orari Gorge Scenic Board (herein referred to as "the Board"), in trust, for the preservation of scenery, and with the powers and subject to the conditions hereinafter contained, that is to say,—

2. The members of the Board shall at their first meeting, and thereafter at the annual meeting hereinafter mentioned,

elect one of themselves to be Chairman, who may join in the discussion, and shall have an original as well as a casting vote. The Chairman shall hold office until the election of his successor.

3. Special meetings may be convened by the Chairman, provided that two days' notice of such meeting is given to each member, specifying the business to be transacted at such special meeting; and no other business than that so specified shall be transacted at such meeting.

4. Any three members of the Board shall form a quorum.
Any meeting may be adjourned from time to time.
5. All questions shall be determined by the majority of votes of the members of the Board present at the meeting.
