Additional Rule and Regulation under the Law Practitioners Act, 1908.

BY virtue of the powers vested in us by law, we, the undersigned Judges of the Supreme Court of New Zealand,

do hereby make the following rule and regulation, to come into force on the 1st day of August, 1921, that is to say:—

1. Clause 14 of the rules and regulations made on the 24th day of April, 1907 (published in the *New Zealand Gazette*, 1908, page 1556), is amended by revoking paragraph (a) thereof and substituting therefor the following paragraph,—
(a) No candidate shall be credited with having passed in less than two subjects at a time, except in the case of the examination which includes the last subject in which the candidate shall pass.
