UNITED STATES OF AMERICA.

NEW YORK AND NEW JERSEY .--- AMBROSE CHANNEL AND FIRE ISLAND LIGHT-VESSELS AND SEA GIRT LIGHT-STATION. -RADIO FOG-SIGNALS ESTABLISHED.

On 1st May, 1921, radio fog-signals were established on Ambrose Channel and Fire Island Light-vessels and at Sea Clirt Light-station, and vessels equipped with radio com-pass installation may determine their bearings from these stations. The signals are operated each day from 9 to 9.30 a.m. and from 3 to 3.30 p.m.; and continuously during thick or foggy weather. Signals are sent on 1,000-meter wave, as follows:

Ambrose Channel Light-vessel: A series of single dashes for 20 seconds, silent 20 seconds.
Fire Island Light-vessel: A series of double dashes for

25 seconds, silent 25 seconds.
