N the recommendation of the Native Land Purchase Board, referred to in section three hundred and sixty three of the Native Land Act, 1909, and in exercise of the power in this behalf conferred upon him by that section, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council thereof, doth hereby extend for a further period of eighteen months the Order in Council dated the twenty-fifth day of February, one thousand nine hundred and twenty, and gazetted the fourth day of March, one thousand nine hundred and twenty, but only in so far as it affects the Native land specified in the Schedule hereto, prohibiting all alienation other than alienation in favour of the Crown.
