And whereas it is deemed expedient that the land mentioned in the Schedule hereto, which is so held on renewable lease under the Land Act, 1908, should cease to be nationalendowment land :

Now, therefore, in pursuance and exercise of the powers and authorities so conferred upon me by the aforesaid section eleven, I, John Rushworth, Viscount Jellicoe, Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, do hereby proclaim and declare that from and after the date of the gazetting hereof the land described in the Schedule hereto, which was set apart as national-endowment land under the provisions of section two hundred and fifty-cight of the Land Act, 1908, shall cease to be nationalendowment land.
