Regulations as to deer "tags," per New Zealand Gazette No. 40, Vol. I, of 20th May, 1909, shall be strictly adhered to by each licensee, who, in addition thereto, shall return all unused "tags" to the secretary of the Westland Acclimatization Society, Hokitika, immediately he has finished stalking for the season for which such "tags" have been issued, together with a statement of the number of deer shot.

## REGULATIONS.

1. FALLOW-DEER bucks may be taken or killed within the Grey District Acclimatization District from the 26th day of March, 1921, to the 13th day of June, 1921, both days

2. Licenses to take or kill such deer may be issued by the 2. Licenses to take or kill such deer may be issued by the Chief Postmaster at Greymouth, on payment of a license fee of £2, in the form prescribed in the Schedule hereto, and subject to the said Act and these regulations. The number of such licenses shall not exceed fifteen; provided that not more than one such license shall be issued to the same person.

3. No licensee shall take or kill more than four bucks, and no buck shall be killed carrying antlers with less than four points.

4. No doe or fawn shall be taken or killed on any pretext whatever; and no licensee shall allow any dog to accompany either himself or any attendant he may have with him.

5. Nothing herein contained shall extend to authorizing any person to sell any deer or portion thereof.
