CERTIFICATE.

I, DONALD NORMAN WATSON MURRAY, the Medical Officer in attendance at the execution of Hakaraia te Kahu at the prison of Mount Eden, Auckland, do hereby certify and declare that I have this day witnessed the execution of the said Hakaraia te Kahu at the said prison; and I do hereby further certify and declare that the said Hakaraia te Kahu was, in pursuance of the sentence of the Supreme Court, hanged by the neck until his body was dead.

DECLARATION.

We do hereby testify and declare that we have this day been present when the extreme penalty of the law was carried into execution on the body of Hakaraia te Kahu, convicted at the criminal sittings of the Supreme Court held at Hamilton on the 6th day of September, 1921, and sentenced to death, and that the said Hakaraia te Kahu was, in pursuance of the said sentence, hanged by the neck until his body was dead.
