Proposed Boundaries of the Electoral Districts in the North | Island of New Zealand.

THE North Island Representation Commission appointed under the Legislature Act, 1908, in pursuance of section 21 of the said Act, hereby publish for general information the following proposed boundaries of the electoral districts in the North Island; and further, give notice that written objections to the same will be received by the undersigned, the Chairman of the said Commission, at the office of the Surveyor General, Wellington, not later than noon on Monday, the 9th day of January, 1922, for consideration by the aforesaid Commission.

Maps of the proposed districts may be seen at the offices of the several local bodies in the said North Island; of the Chief Surveyors at Auckland, New Plymouth, Napier, and Wellington; of the Chief Electoral Officer at Wellington; and of the several Registrars of Electors throughout the North Island aforesaid.

# NORTH ISLAND ELECTORAL DISTRICTS.

# BAY OF ISLANDS.

BAY OF ISLANDS District comprises the existing Bay of Islands Electoral District together with the Town District of Hikurangi and that portion of Hikurangi Riding of Whangarei County lying to the north-east of the Mangahahuru River; also that portion of the Mangakahia Riding of the said county lying to the south of the existing electoral boundary, and less that portion of Tangowahine Riding of Hobson County lying to the North of the existing electoral boundary and the southern boundary of Whangarei County.

# KAIPARA.

Kaipara District comprises the existing Kaipara Electoral District less that portion of the Mangakahia Riding of

Whangarei County now included in the Bay of Islands Electoral District hereinbefore described. This district now includes that portion of the Tangowahine Riding of Hobson County lying to the north of the existing electoral boundary and the southern boundary of Whangarei County, together with the whole of the Mairetahi, Kumeu, Pukeatua, Birkenhead, and Takapuna Ridings of Waitemata County, less those portions of the aforesaid Birkenhead and Takapuna Ridings lying to the south of the northern boundary of Section 126, Blocks XI and XII, Waitemata Survey District, the northern boundary of Section 124, Blocks VIII and XII, the northern boundary of Section 219, the north-western boundary of Section 219, the north-western boundaries of Sections 218, 110, 109, 108, 107, 106, and the north-western and north-eastern boundaries of Section 105 of the aforesaid block and survey district; also less the whole of the Wainui Riding of Waitemata County and that part of the Kaukapakapa Riding of the said county lying to the north-east of the Makarau River; also less the Puhoi Riding of Rodney County lying to the north-east of the Section 124, Blocks XI and XII, Otamatea Survey District, and the south-western boundaries of Sections 123, 122, 121, and north-eastern boundaries of Sections 123, 122, 121, and north-eastern boundaries of Section 126, Block XII, Section 125, Blocks XII and XVI, and the road continuing from the southernmost corner of the said Section 125 of the aforesaid block and survey district to the aforesaid riding boundary at the road by Wellsford Railway-station.

# MARSDEN.

Marsden District comprises the existing Marsden Electoral District together with the Puhoi and part of the Albert Ridings of Rodney County, also the Wainui and part of the Kaukapakapa Ridings of Waitemata County now excluded from the Kaipara Electoral District hereinbefore described; less the Town District of Hikurangi and that portion of the Hikurangi Riding of Whangarei County now included in the Bay of Islands Electoral District hereinbefore described. This district now includes Motu Hinou, Morotiri, Heu, Kawau, Moutuketekete, Moturekareka, Motuhoro, Tiritiri, and adjacent islands.

#### WAITEMATA.

Waitemata District comprises the whole of the Boroughs of Devonport, Takapuna, Northcote, and Birkenhead, also those portions of the Birkenhead and Takapuna Ridings of Waitemata County not included in the Kaipara Electoral District hereinbefore described.

#### EDEN.

Eden District comprises the existing Eden Electoral District less the Mairetahi Riding of Waitemata County and that portion of the Kumeu Riding of the said county now included in the Kaipara Electoral District hereinbefore described.

# AUCKLAND WEST.

Auckland West District comprises the existing Auckland West Electoral District less that portion bounded on the north by Napier Street, on the east by Hepburn Street, on the south by Wellington Street, and on the west by Franklin Street. This district now includes Great Barrier Island County, Little Barrier, Rangiahua, and adjacent islands.

# AUCKLAND CENTRAL.

AUCKLAND CENTRAL.

Auckland Central District comprises the existing Auckland Central Electoral District with the addition of that portion of Auckland City now excluded from the Auckland West Electoral District hereinbefore described; less that portion bounded on the east generally by Upper Queen Street, East Street, and Benedict Street; towards the south-west and north-west by Newton Road to Gundry Street, by Gundry Street to Montague Street, by Montague Street to Edwin Street, by Edwin Street to France Street, by France Street to East Street, by East Street to Karangahape Road; towards the north by Karangahape Road to Upper Queen Street.

#### AUCKLAND EAST.

Auckland East District comprises the existing Auckland East Electoral District together with that portion of Auckland City now excluded from the Auckland Central Electoral District hereinbefore described; less that portion bounded on the south by the boundary between Sections 36A and 37A from Manukau Road to its intersection with the Auckland Domain, thence along the boundary of the said Domain to its north-eastern corner, thence by a right line to the junction of Falcon Street with Henly Street, by Henly Street to Manukau Road, thence by Manukau Road, Alpha Road, and Gittos Street to the junction of Gittos Street and the Strand, thence by the Strand to St. George's Bay Road.

# GREY LYNN

Grey Lynn District comprises the existing Grey Lynn Electoral District, the boundaries of which are unaltered.

# PARNELL.

Parnell District comprises the existing Parnell Electoral District together with that portion of Auckland City now excluded from the Auckland East Electoral District herein-before described; less the Parnell Riding of Eden County and that portion of the Tamaki Riding of the said county from the Tamaki River at Tamaki Bridge to and along the south-western and western boundaries of the Panmure Townsouth-western and western boundaries of the Fahmure Township to and along the Pahmure-Howick Road to the Auckland City boundary; also less that portion of Auckland City bounded on the north by the Auckland City boundary on the southern side of Purewa Creek, on the east and south generally by the said Auckland City boundary to the road thrown as the Ladica' Mile toward the proof of the control known as the Ladies' Mile, towards the west generally by the Rnown as the Ladies Mile to the Remuera Road, thence by the said Remuera Road and St. John's College Road to the south-eastern corner of Section 238 (Native Reserve), thence by the eastern boundary of the said Section 238 to the Orakei Creek, and by that creek to the aforesaid Auckland City boundary at Purewa Creek.

# ROSKILL.

Roskill District comprises the existing Roskill Electoral District less that portion of the Mount Roskill Road District lying to the south generally of Richardson Road from the southernmost corner of Section 91, along the said Richardson Road, to and along May Road and its continuation to the Albert Road at the easternmost corner of the western portion of Section Part 47, thence by the said Albert Road to the Three Kings Road, thence by the said Three Kings Road to its intersection with the northern boundary of the said Mount Roskill Road District.

# MANUKAU.

Manukau District comprises the whole of Eden County less that portion known as the Auckland Domain, that portion of the Mount Roskill Road District of the said Eden County included in the Roskill Electoral District hereinbefore described, also the Avondale Road District of the aforesaid

Eden County included in the Eden Electoral District hereinbefore described, also that portion of the One-tree Hill Road District of the aforementioned Eden County included in the Parnell Electoral District hereinbefore described. This disrather Electoral District neterine does described. This district also includes that portion of the Ellerslie Town District not included in the said Parnell Electoral District, also the whole of the Borough of Onehunga and the whole of Mangere Riding of Manukau County and Week's Island.

#### FRANKLIN.

Franklin District comprises the Boroughs of Otahuhu and Pukekohe, the Town Districts of Papatoitoi, Manurewa, and Papakura, the whole of the Papatoitoi, Papakura, Pakuranga, and Turanga Ridings of Manukau County, that portion of the Wairoa Riding of the said Manukau County lying to the west of the Wairoa River from the southern boundary of the aforesaid Manukau County to the road intersecting Section 20, Wairoa Parish, and forming the western boundary of Sections 44, 45, and 46 of the said Wairoa Parish to its intersecton with the western boundary of the aforesaid Wairoa Riding; also the whole of the Awhitu, Mauku, and Karaka Ridings of Franklin County and that portion of the Pukekohe West Riding of the said Franklin County lying to the north West Riding of the said Franklin County lying to the north and east of the Waiuku Road from the south-western corner of Section 15, Block XIV, Drury Survey District, to its intersection with the western boundary of Pukekohe Borough; also that portion of the Pukekohe East Riding of the aforesaid Franklin County lying to the north of the road intersecting Sections 12, 15, 30, and 26, Blocks XI, XII, XV, and XVI, of the said Drury Survey District from the eastern boundary of the aforesaid borough of Pukekohe to the eastern boundary of the said Section 26: thence by the eastern boundary of the said Section 26; thence by the eastern boundary of the aforesaid Section 26, and eastern boundaries of Sections 7 and 54, Block XII, of the aforesaid Drury Survey District to the north-eastern boundary of the said Pukekohe Riding; also that portion of the Drury Riding of Franklin County lying to the north-west of the road forming the eastern boundary of Section 51, Block XII, Drury Survey District, and passing through Sections 50 and 49 and forming the eastern boundary of the said Section 49 of the said block and survey district; thence by that road from the north-eastern boundary of the said Section 49 to the north-western boundary of Section 148, Block VIII, of the said Drury Survey District, and by the northern boundary of the said Section 148 and northern boundary of Section 34 of the aforesaid block and survey district to the south-western boundary of the Hunua Riding of the said Franklin County; also that portion of the Hunua Riding of the sate Franklin County lying to the west of the Wairoa River from the southern boundary of Manukau County to the stream forming the southern boundary of Hunua Parish, and by that stream to its junction with the said Hunua Riding. This district now excludes the Waiuku and Tuakau Town Districts.

# THAMES.

Thames District comprises the existing Thames Electoral District together with that portion of the Wairoa Riding of Manakau County not included in the Franklin Electoral District hereinbefore described, also those portions of the Drury and Hunua Ridings of Franklin County, not included in the said Franklin Electoral District.

# OHINEMURI.

Ohinemuri District comprises the existing Ohinemuri Electoral District with the addition of that portion of the Kirikiriroa Riding of Waikato County bounded towards the north-west by the western boundaries of Lots Part 26 as shown on Land Transfer Plans 6754 and 3792A, from the Te Aroha Railway-line to and along the road forming the north-eastern boundary of the said Lot Part 26 to the afore-said railway-line; thence by that railway-line to its intersection with the eastern boundary of the said Waikato County, thence in a south-easterly direction by the said county boundary to the road at the south-eastern corner of Lot 1 as shown on Land Transfer Plan 3777; thence in a southwesterly direction by the road forming the southern boundary of the said Lot 1, western boundary of Lot 4, passing through Lots 2 and 3, as shown on Land Transfer Plan 5865, to the junction of roads at the southernmost corner of Lot 1, as shown on Land Transfer Plan 5403a; thence in a northwesterly direction by the road forming the south-western boundaries of Lots 1 and Lot Part 3, as shown on Land Transfer Plans 5403a and 5466a, to the said Te Aroha Railwayline; thence by that railway-line to the southernmost corner of the said Lot Part 26.

Raglan District comprises the Borough of Ngaruawhia, the Waiuku, Tuakau, Huntly, and Raglan Town Districts, the whole of the Waipipi and Waiuki Ridings of Franklin County, also those portions of the Pukekohe West and Pukekohe East Ridings of the said Franklin County not included in the Franklin and Thames Electoral Districts hereinbefore described; the whole of Raglan County, less the Pirongia Riding of the said Raglan County; the whole of the Newcastle Riding of Waikato County is that portion of the Huntly Riding of Waikato County not included in the Thames Electoral District hereinbefore described, and that portion of the Kirikiriroa Riding of the said Waikato County bounded towards the south-west and north-west generally by the south-western boundary of the aforesaid Waikato County from the road at the southernmost corner of Section 76, Block XII, Newcastle Survey District, to its junction with the north-western boundary of Kirikiriroa Riding, thence towards the north-west by the boundary of the aforesaid Kirikiriroa Riding to its intersection with the existing Ohinemuri Electoral District hereinbefore described, thence towards the north-east generally by the boundary of the said Ohinemuri Electoral District to the road at the south-eastern boundary of Lot 5, Freshfield Estate, as shown on Land Transfer Plan 7136, thence in a south-westerly direction generally by that road to the southernmost corner of the said Section 76.

#### HAMILTON.

This district comprises the Borough of Hamilton, the whole of the Hamilton Riding of Waipa County, the whole of the Tamahere Riding of Waikato County, that portion of the Kirikiriroa Riding of the said Waikato County not included in the Raglan and Ohinemuri Electoral Districts hereinbefore described, together with that portion of the Cambridge Riding of the aforeasid Waikato County lying to the northwest of the road forming the eastern boundaries of Sections 118, 119, and 123, the southern and eastern boundary of Section 100, and the eastern boundaries of Sections 50, 67, 66, 65, 64, and 63 of Block VIII, Hamilton Survey District.

#### TAURANGA.

Tauranga District comprises the existing Tauranga Electoral District, less the whole of the Toatoaroa Riding of Matamata County and the northern portion of the Tirau Riding formerly included in the existing Tauranga Electoral District, also less that portion of the Cambridge Riding of Waikato County not included in the Hamilton Electoral District hereinbefore described.

#### ROTORUA.

This district comprises the Borough of Whakatane, the whole of Whakatane County, the whole of Rotorua County, that portion of the Maketu Riding of Tauranga County bounded on the west and north by the existing Rotorua Electoral District, that portion of East Taupo County lying to the north-east of the said existing Rotorua Electoral District, that portion of West Taupo County bounded on the north-west by the Waipapa River and on the south-west by the aforesaid existing Rotorua Electoral District, also the Tapapa, Okoroire, Tokoroa, and Putaruru Ridings of Matamata County.

# BAY OY PLENTY.

Bay of Plenty comprises the existing Bay of Plenty Electoral District, the boundaries of which are unaltered.

# GISBORNE.

Gisborne District comprises the existing Gisborne Electoral District, the boundaries of which are unaltered.

# NAPIER.

Napier District comprises the existing Napier Electoral District, with the addition of that portion of the Meeanee Riding of Hawke's Bay County formerly included in the existing Hawke's Bay Electoral District, less that portion of the said Meeanee Riding bounded on the north by the northern boundary of Section 43, Block VII, Heretaunga Survey District, on the east by the road forming the eastern boundaries of the said Section 43 and Section 60 of the said block and survey district, and on the south by the northern boundary of the Taradale Town District.

# HAWKE'S BAY.

Hawke's Bay District comprises the existing Hawke's Bay Electoral District, together with that portion of the Meeanee Riding of Hawke's Bay County bounded on the north by the northern boundary of Section 43, Block VII, Heretaunga Survey District, on the east by the road forming the eastern boundaries of the said Section 43 and Section 60 of the said block and survey district, and on the south by the northern boundary of the Taradale Town District, less that portion of the said Meeanee Riding now included in the Napier Electoral District hereinbefore described.

#### WAIPAWA.

Waipawa District comprises the existing Waipawa Electoral District, less the whole of the Matamau Riding of Dannevirke County, also less that portion of the Dannevirke Riding of the said Dannevirke County lying to the north and east of the southern and western boundaries of the existing Waipawa Electoral District.

#### Рантатиа.

Pahiatua District comprises the existing Pahiatua Electoral District together with the whole of the Matamau Riding of Dannevirke County, also that portion of the Dannevirke Riding of the said Dannevirke County lying to the north and east of the existing Pahiatua Electoral District, and less the whole of the Waihi and Akitio Ridings of Akitio County now included in the Masterton Electoral District hereinafter described.

#### MASTERTON.

Masterton District comprises the existing Masterton Electoral District together with the whole of Waihi and Akitio Ridings of Akitio County, and less that portion of the Rangistumau Riding of Masterton County lying to the north and west of the existing Masterton Electoral District and the Wangaehu Valley Road, and less that portion of the East Riding of Mauriceville County lying to east of the said Wangaehu Valley Road, Barton's Road, and Barton's Line, and less that portion of the Alfredton Riding of Eketahuna County bounded towards the west by Barton's Line to the junction of roads in Section 109, Block XII, Mangaone Survey District; thence in a north-easterly direction by the road from the said junction to the junction of roads in the Moroa Native Reserve; thence in a north-easterly direction by the road from the said Native Reserve to its junction with the Tiraumea Valley Road, and bounded towards the north by the said Tiraumea Valley Road, Alfredton-Weber Road, and Waihoki Valley Road; also less the whole of the Mataikona Riding of Akitio County and that portion of the Pongaroa Riding of the said Akitio County lying to the south-east of the road running in a north-easterly direction from Spur Road in Section 2, Block XI, Aohanga Survey District, to the junction of roads in Section 130, Block VII, of the said survey district; thence in a north-easterly direction by the road from the said junction to the Aohangi River at Section 136, Block VII, of the aforesaid Aohanga Survey District.

#### WAIRARAPA.

Wairarapa District comprises the existing Wairarapa Electoral District together with those portions of the Rangitumau Riding of Masterton County, the East Riding of Mauriceville County, the Alfredton Riding of Eketahuna County, the whole of the Mataikona Riding, and that portion of the Pongaroa Riding of Akitio County now excluded from the existing Masterton Electoral District hereinbefore described.

# Нитт.

Hutt District comprises the existing Hutt Electoral District less that portion of the Mungaroa Riding of Hutt County lying between the eastern, western, and northern boundaries of the said existing Hutt Electoral District from the Hutt River at the north-western corner of Section 83, Block IV, Belmont Survey District; thence by the north-eastern boundary of the said Section 83, Block IV, Belmont Survey District, to the road forming the south-eastern boundary of the aforesaid Section 83; thence in a north-easterly direction by that road to its junction with the No. 1 Line; thence in a south-easterly direction by the said No. 1 Line to its junction with Whiteman's Valley Road, and by that road to its intersection with the south-western boundary of Section 24, Block V, Rimutaka Survey District; thence by the south-western and south-eastern boundaries of the said Section 24 and along the north-eastern boundaries of Sections 25 and 26 of the said block and survey district, and along the north-eastern boundaries of Sections 27 and 97, Block VIII, of the aforesaid Rimutaka Survey District to the north-western corner of the Wellington Waterworks Reserve; thence by the north-eastern boundary of the said Waterworks Reserve to its intersection with the eastern boundary of the aforesaid Hutt Electoral District.

# WELLINGTON NORTH.

Wellington North District comprises the existing Wellington North Electoral District with the addition of that portion of Wellington City bounded towards the south by the existing Wellington Central Electoral District from Norma Crescent to the Kaiwarawara Stream; bounded towards the west by the said Kaiwarawara Stream to a point in line with the middle of Thorby Street, thence by a right line to Thorby Street, thence by Thorby Street to its junction with the Northland Garden Road, by that road to Farm Road, by Farm Road to Creswick Road, by Creswick Road and its

production to the said Kaiwarawara Stream, and by that stream to the northern boundary of Section Part 31; bounded towards the north by the northern and eastern boundaries of the said Section Part 31 to the northern boundary of Section Part 30, and by the northern boundary of the said Section Part 30 and its production to the existing Wellington North Electoral District on the eastern side of the Wireless Telegraph Station Reserve.

# WELLINGTON CENTRAL.

Wellington Central District comprises the existing Wellington Central Electoral District together with that portion of Wellington City bounded towards the north-east by Rugby Street from Tasman Street to Adelaide Road, bounded towards the south-east by the said Adelaide Road from the said Rugby Street to Drummond Street, bounded towards the south-west by Drummond Street from the said Adelaide Road to the said Tasman Street; that portion bounded towards the north-west generally by the Wellington Watersupply (catchment area) from the Kaiwarawara Stream to the south-western corner of Section Part 2, thence by a right line to the easternmost corner of original Section I, thence by a right line to the existing Wellington Central Electoral District at the north-eastern corner of Section Part 11; also that portion of Central Park lying north of a right line from Tanera Crescent to the southernmost corner of original Section 55.

# WELLINGTON EAST.

Wellington East District comprises the existing Wellington East Electoral District less that portion now included in the Wellington Central Electoral District hereinbefore described; also less that portion of Wellington City lying to the southeast of Ross Street from Cook Street to Coutts Street; thence by the said Coutts Street to Salek Street; thence by the said Salek Street to Seatoun Road; thence by the said Seatoun Road to a point in line with the south-eastern boundary of Lot 45, thence to and along the said boundary of the said Lot 45 to Evans Bay.

# WELLINGTON SOUTH.

Wellington South District comprises the existing Wellington South Electoral District together with that portion of Wellington City commencing at the junction of Herald Street with Russell Street; thence along Russell Street to Leraud Street; thence by Leraud Street to Duppa Street; thence by Duppa Street to Stanley Street; thence by Stanley Street to a point in line with the southern boundary of Lot 27; thence by the southern boundary of the said Lot 27, southern boundaries of Lot 26, Emerson Street, and Lot 1, to the south-western corner of the said Lot 1; thence by the western boundary of the aforesaid Lot 1, western boundaries of Lots 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, and 15, Morton Street, Lot 16, and the Levin Home to Britomart Street; thence by Britomart Street and its production to the western boundary of the Municipal Golf-links; thence towards the south and west generally by the western boundary of the said Municipal Golf-links to the south-western corner of same; thence by a right line to the north-western corner of Lot 3, Part of original Section 23, at Happy Valley Road; thence in a northerly direction by the said Happy Valley Road to the existing Wellington South Electoral District boundary.

# WELLINGTON SUBURBS.

Wellington Suburbs District comprises the existing Wellington Suburbs Electoral District together with that portion of Wellington City now excluded from the Wellington East Electoral District hereinbefore described, less those portions of the said Wellington City now included in the Wellington South, Wellington Central, and Wellington North Electoral Districts hereinbefore described, also less the whole of the Johnsonville Town District.

# OTAKI.

Otaki District comprises the existing Otaki Electoral District together with the whole of the Johnsonville Town District, and that portion of the Mungaroa Riding of Hutt County now excluded from the Hutt Electoral District hereinbefore described; less the whole of the Borough of Levin, and that portion of the Wirikino Riding of Horowhenua County bounded towards the south by the road running from the Ocean at Hokio Township to the south-western corner of the said Borough of Levin, and bounded towards the east by the north-western and north-eastern boundaries of the aforesaid Borough of Levin to the Main Trunk Railway, and by that railway to its intersection with the existing Otaki Electoral District boundary.

# MANAWATU.

Manawatu District comprises the existing Manawatu Electoral District together with that portion of the Wirikino Riding of Horowhenua County not included in the Otaki

Electoral District hereinbefore described, less that portion of the extension of the Borough of Feilding lying between the existing Manawatu Electoral District boundary and the southern and western boundaries of the said borough, also less the whole of the Otakapau Riding of Rangitikei County.

#### PALMERSTON.

Palmerston District comprises the existing Palmerston Electoral District less that portion of the Mangaone Riding of Kairanga County lying to the north-east of Roberts Line and the Tematai Road, also that portion of the Fitzherbert Riding of the said Kairanga County lying to the north-east of a line commencing at the Manawatu River at a point in line with the north-eastern boundary of Section 235, Block XII, Kairanga Survey District; thence to and along the said north-eastern boundary of the said Section 235 to the north-western boundary of Section 301, Block XVI, of the said Kairanga Survey District; thence by the said north-western boundary of the said Section 301 to the Palmerston-Pahiatua Road, and by that road to the south-eastern boundary of the Hiwinui Riding of Oroua County; also less that portion of the Hiwinui Riding of Oroua County lying between the said existing Palmerston Electoral District boundary and the south-eastern and south-western boundaries of the said Oroua County.

#### OROUA.

Oroua District comprises the existing Oroua Electoral District together with those portions of the Mangaone and Fitzherbert Ridings of Kairanga County now excluded from the Palmerston Electoral District hereinbefore described; that portion of the Hiwinui Riding of Oroua County now excluded from the said Palmerston Electoral District; also that portion of the Borough of Feilding lying to the south-west of the existing Oroua Electoral District boundary and the southern and western boundaries of the said borough.

#### RANGITIKEI.

Rangitikei District comprises the existing Rangitikei Electoral District together with the whole of the Otakapau Riding of Rangitikei County.

#### Wanganui.

Wanganui District comprises the existing Wanganui Electoral District, the boundaries of which are unaltered.

#### PATEA.

Patea District comprises the existing Patea Electoral District, the boundaries of which are unaltered.

# EGMONT.

Egmont District comprises the existing Egmont Electoral District, together with that portion of Egmont County lying between the existing Egmont Electoral District boundary and the north-eastern boundary of the said Egmont County.

# TARANAKI.

Taranaki District comprises the existing Taranaki Electoral District less that portion of Egmont County now included in the Egmont Electoral District hereinbefore described, also less that portion of Inglewood County lying between the existing Taranaki Electoral District boundary and the northwestern boundary of the said Inglewood County.

# STRATFORD.

Stratford District comprises the existing Stratford Electoral District together with that portion of Inglewood County lying between the existing Stratford Electoral District boundary and the north-western boundary of the said Inglewood County.

# WAIMARINO.

Waimarino District comprises the existing Waimarino Electoral District, the boundaries of which are unaltered.

# WAITOMO.

Waitomo District comprises the existing Waitomo Electoral District, the boundaries of which are unaltered.

# WAIKATO.

This district comprises the Boroughs of Cambridge and Te Awamutu, the whole of Kawhia County, the whole of the Pirongia Riding of Raglan County, the whole of the Te Rauamoa Riding of Waitomo County, and that portion of the Otorohanga Riding of the said Waitomo County not included in the Waitomo Electoral District hereinbefore described; the whole of Waipa County, less the whole of the Newcastle and Hamilton Ridings; that portion of the Cambridge Riding of Waikato County not included in the Hamilton Electoral District hereinbefore described; the whole of the Toatoaroa, Tirau, and Maungatautari Ridings of Matamata County, also that portion of West Taupo County lying to the north-west of the Waipapa River.

#### WESTLAND.

Westland District comprises the existing Westland Electoral District together with those portions of the Waipuna and Nelson Creek Ridings of Grey County lying between the existing Buller Electoral District boundary and the Grey River.

Motueka District includes the existing Motueka Electoral District together with the whole of the Moutere Riding of Waimea County, the whole of the Dovedale Road District of Dovedale Riding of the said Waimea County, also that portion of the said Dovedale Riding lying between the northwest boundary of the said Dovedale Road District and the boundary of the existing Motueka Electoral District; also those portions of the Whangapeka, Motupiko, Wai-iti, Appleby, and Stoke Ridings of the said Waimea County formerly included in the existing Wairau Electoral District hereinafter described; less the whole of the Karamea and Mokihinui Ridings of Buller County now included in the Buller Electoral described; less the whole of the Karamea and Mokininu Ridings of Buller County now included in the Buller Electoral District hereinbefore described; also less those portions of the Boatman's and Antonio's Ridings of Inangahua County now included in the said Buller Electoral District.

# NELSON.

Nelson District comprises the existing Nelson Electoral District together with that portion of the Sounds County lying to the north of the watershed extending from the northeastern boundary of the Marlborough County to the head of the Kenepuru Sound and Miritu Bay, and westward along the boundary of the Forest Reserve to Te Puru Bay, and including the Forsyth, Maud, Chetwode, Trio, and adjacent islands; and less the Moutere Riding of Waimea County.

# WAIRAU.

Wairau District comprises the existing Wairau Electoral District less the whole of that portion of Waimea County lying between the north-western, north-eastern, south-eastern, and south-western boundaries of the existing Wairau Electoral District; also less that portion of Sounds County now included in the Nelson Electoral District hereinbefore described. This district now includes the whole of that portion of the Marlborough County lying to the south-west of the said existing Wairau Electoral District boundary, together with the whole of the Awatere County.

#### HURUNUI.

Hurunui District comprises the existing Hurunui Electoral District less that portion of the Marlborough County and the whole of the Awatere County now included in the Wairau Electoral District hereinbefore described; includes the whole of the Kaikoura, Cheviot, Waipara, Tawera, Kowai, and Ashley Counties, the whole of the North Riding of Oxford County, that portion of the South Riding of Oxford County lying to the north-west of the railway-line, together with the whole of the Sheffield Riding of Malvern County.

#### KAIAPOL

Kaiapoi District comprises the existing Kaiapoi Electoral District, together with the Papanui Riding of Paparua County, and that portion of the Avon Riding of Waimairi County lying to the south and east of the existing Kaiapoi Electoral District boundary; and less the whole of the North Riding of Oxford County and that portion of the South Riding of the said Oxford County now included in the Hurunui Electoral District hereinbefore described.

#### CHRISTCHURCH NORTH.

Christchurch North District comprises the existing Christchurch North Electoral District together with that portion of the existing Avon Electoral District bounded on the north of the existing Avon Electoral District bounded on the north by Fowke Street, on the east by Perth Street, on the south by London Street, and on the west by North Avon Road; also that portion of the existing Avon Electoral District bounded on the north by Bealey Avenue, on the east by the extension of North Avon Road to Heywood Terrace, on the west by the road in line with Queen Street; and less that portion of Christchurch City bounded on the north by Kilmore Street, on the east by Colombo Street, on the south by Armagh Street, and on the west by York Street.

#### CHRISTCHURCH EAST.

Christchurch East District comprises the existing Christchurch East Electoral District together with that portion of Christchurch City bounded on the north by St. Asaph Street, on the east by Phillips Street, on the south by Ferry Road, and on the west by Fitzgerald Avenue; and less that portion of Christchurch City, commencing at the intersection of Ensor's Road and the Christchurch-Lyttelton Railway, bounded on the north-east by the said railway, on the east and south by the Heathcote River, and on the west and north by the said river and Ensor's Road to the point of commencement.

# CHRISTCHURCH SOUTH.

Christchurch South District comprises the existing Christchurch South Electoral District together with that portion of Christchurch City now excluded from the Christchurch North Electoral District hereinbefore described.

# Avon.

Avon District comprises the existing Avon Electoral District less those portions of Christchurch City now included in the Christchurch North, the Christchurch East, and the Kaiapoi Electoral Districts hereinbefore described.

# RICCARTON.

Riccarton District comprises the existing Riccarton Electoral District less the whole of the Sheffield Riding of Malvern County now included in the Hurunui Electoral District here-County now included in the Hurunui Electoral District hereinbefore described; also less the whole of the Papanui Riding of Waimairi County now included in the Kaiapoi Electoral District hereinbefore described. This district now includes the whole of Riding No. 1 of Halswell County and that portion of No. 2 Riding of the said county lying to the north of the south-eastern boundary of Section No. 4734 and the road forming the north-eastern boundary of Sections 338A and 338B; also includes that portion of the Homebush and Courtenay Ridings of Malvern County formerly included in the existing Ellesmere Electoral District. Lyttelton District comprises the existing Lyttelton Electoral District together with that portion of Christchurch City now excluded from the Christchurch East Electoral District hereinbefore described.

# ASHBURTON.

# TIMARU.

Timaru District comprises the existing Timaru Electoral District less those portions of the Waimaitaiti and Seadown Ridings of Levels County hereinbefore described.

# Waitaki.

Waitaki District comprises the existing Waitaki Electoral District together with the whole of the Puketoi and Hyde Ridings of Maniototo County, the whole of the Greenvale, Dunback, and Macrae's Ridings of Waihemo County, the whole of the Hawksbury Riding and Waikouaiti Riding of Waikouaiti County; also the whole of the Merton Riding of the said county less that portion lying to the east of the Main South Road south of the road forwing the arthur boundary. South Road, south of the road forming the northern boundary of Section 26, passing through Section 33, forming the northern boundaries of the aforesaid Section 33, 83, 82, the northern and north-eastern boundary of Section 33, 83, 82, the northern and north-eastern boundary of Section 81, north-east boundary of Section 80, Block I, Waikouaiti Survey District; less the Upper Pareora, Lower Pareora, and Otaio Ridings of Waimate County, now included in the Temuka Electoral District hereinbefore described.

# DUNEDIN NORTH.

Dunedin North District comprises the existing Dunedin North Electoral District together with the Sawyer's Bay Ward of the West Harbour Borough, and that portion of Waikouaiti County lying to the south-west of the eastern boundaries of Sections 55, 54, and 52, Block VIII, of the North Harbour and Blueskin Survey Districts and the boundary of Dunedin City; also those portions of Dunedin City lying between King and Cumberland Streets, Albany and Frederick Streets and between Elder and London Streets, Pitt and Argyle Streets.

# DUNEDIN WEST.

Dunedin West District comprises the existing Dunedin West Electoral District together with that portion of Dunedin West Electoral District together with that portion of Duneam City bounded on the south generally by High Street and the Mornington Cable Tramway to Woodhead Street, to its junction with the Glen Avenue; thence along that avenue to Hawthorn Avenue, along that avenue to District Road; thence along that road to its intersection with the northern boundary of Lots 14 to 18 of Richmond Hill Subdivision; thence along the said boundary to its intersection with the eastern boundary of Block IX, Dunedin and East Taieri District; thence along the said boundary to the District Road, and along that road to its intersection with the southern boundary of the said Block IX; thence along the said southern boundary to its junction with the existing boundary of the Dunedin North Electoral District at the south-east corner of Section 17, Kaikorai District; and less those portions of Dunedin City now included in the Dunedin North Electoral District hereinbefore described.

#### DUNEDIN CENTRAL.

Dunedin Central District comprises the existing Dunedin Central Electoral District together with that portion of Dunedin City now excluded from the Dunedin South Electoral District hereinafter described; and less that portion of the said Dunedin City now included in the Dunedin West Electoral District hereinbefore described

#### DUNEDIN SOUTH.

Dunedin South District comprises the existing Dunedin South Electoral District together with the Borough of Mosgiel South Electoral District together with the Borough of Mosgiel and less that portion of Dunedin City bounded towards the south generally by Cargill Road to Forbury Road, and by that road to the road forming the north-western boundaries of Sections Nos. 1, 4, 5, and 7, Kew; thence by the road forming the south-western boundary of Sections Nos. 7 and 8, Kew, to Victoria Road, and its extension to the north-eastern corner of Section 13, Caversham, and by the north-eastern boundary of the said Section No. 13 to Playfair Road; thence by the northern boundary of Section No. 2 to Great Queen Street; thence by that street to the Main South Road, and by that road to the existing Dunedin South Electoral District boundary at Caversham Road.

This district also includes Quarantine Island.

# INVERCARGILL.

Invercargill District comprises the existing Invercargill Electoral District together with the whole of the Extension of the Borough of Invercargill lying to the west of the existing Invercargill Electoral District boundary.

# WALLACE.

Wallace District comprises the existing Wallace Electoral District together with that portion of the Hokonui Riding of Southland County lying to the north of the existing electoral boundary of the Awarua Electoral District; also that portion of the Mataura Riding of the said Southland County lying to the south-west of the existing Awarua Electoral District boundary and north-west of the Okapua Creek; also that portion of the Winton Riding of the said Southland County lying to the east of the existing Awarua Electoral District lying to the east of the existing Awarua Electoral District

Mataura District comprises the existing Mataura Electoral District together with that portion of the Mataura Riding of Southland County lying west of the existing Mataura Electoral District boundary, and bounded on the north and east by the western boundary of Clutha County, and on the east by the western boundary of Clutha County, and on the south by the southern boundary of the said Mataura Riding of the said Southland County; also the whole of the Toetoes Riding of the aforesaid county, less that portion now included in the Awarua Electoral District hereinbefore described; also the whole of the Waipahi, Clinton, and Maclennan Ridings of Clutha County, and the whole of the Catlins Riding of the said Clutha County less that portion lying between the Catlins River, Catlins Lake, and the north-east boundary of the said riding and hounded on the north-west boundary of the said riding, and bounded on the north-east by the road running from the north-east corner of Section 33, Block VII, Glenomaru Survey District to the said riding and bounded on the north-east corner of Section 34, Block VII, Glenomaru Survey District to the said to t by the road running from the north-east corner of Section 33, Block VII, Glenomaru Survey District, to the Owaka River in Section 7, Block VI, of the said survey district; thence by that river to the northernmost corner of Section 11, Block VIII, of the said survey district; thence by the south-eastern boundary of Section 6 to the road at the south-eastern corner of the said section, and by that road to the Catlins Lake in Section 37 E.R. of the said block and survey district. survey district.

#### WAKATIPU.

Wakatipu District comprises the existing Wakatipu Electoral District together with the whole of the Crookston Riding of Tuapeka County and that portion of the Beaumont Riding of the said Tuapeka County lying to the south of the northern boundary of Blocks 9 and 17 and the eastern boundaries of Blocks 17 and 13, Crookston Survey District, and the southwestern boundary of the said Beaumont Riding, the whole of Brown's Riding of the aforesaid Tuapeka County, and that portion of Gabriel's Riding of the aforesaid county lying to the south-east of the Beaumont River, less the whole of the Puketoi and Hyde Ridings of Maniototo County, also less those portions of the Strath Taieri and Deep Stream Ridings of Taieri County lying to the north-west generally of the existing Bruce Electoral District. This district also includes the Borough of Lawrence.

# CLUTHA.

Clutha District comprises the existing Clutha Electoral District together with the whole of the Balmoral No. 1 and No. 2, Crichton and Kaitangata Ridings of Bruce County; that portion of the Mataura Riding of the said Bruce County lying to the north-east of the Clutha River; the whole of the Lovelsbrook and Adamsthorpe Road Districts of Mount Stuart Riding of the said Bruce County, and that portion of the Glenore Road District of the said riding lying west of the railway-line; also that portion of the Tokomairiro Riding of the aforesaid Bruce County lying to the southwest of the Tokomairiro River and the railway-line; and less those portions of the Southland, Clutha, and Tuapeka Counties now included in the Mataura and Wakatipu Electoral Districts hereinbefore described. This district also includes the Boroughs of Milton, Kaitangata, Tapanui, and Balclutha.
