"That the Auckland City Council, having control of Wairakei Street, Remuera, Auckland, by resolution declares that the provisions of section one hundred and seventeen of the Public Works Act, 1908, shall not apply to the portion of Wairakei Street fronting Lot 12 of subdivision of Lot 31, and part Lots 26, 27, 29, and 30 of Allotment 6. Section 12, Suburbs of Auckland";
