6. With the written permission of the Commissioner of Crown Lands the lessee may (a) cultivate a portion of the reserve and grow winter feed thereon, (b) plough and sow in grass any area, (c) surface-sow in grass any portion of the reserve.

7. On expiry of lease the value of lessee's improvements will be fixed and protected.

8. Lease is liable to forfeiture if conditions are violated.
