

Situated on the Wanganui River Road, about seven miles from Taumarunui by dray-road, which (with the exception of about half a mile of a loose papa bluff) is generally in fair condition. The sections comprise flat and undulating fern and scrub land, practically all ploughable, and could be cultivated profitably. Soil is of fair quality, resting on clay and pumice. Watered by small swamps. Elevation ranges from 600 ft. to 650 ft. above sea-level.
