*Canceling the Reservation over Portion of a Primary-education Endowment in the North Auckland Land District, and reserving Crown Land in lieu thereof.*

IN pursuance and exercise of the powers and authorities conferred upon me by section thirty-seven of the Land Laws Amendment Act, 1914, I, John Rushworth, Viscount Jellicoe, Governor-General of the Dominion of New Zealand, deeming it expedient in the public interest so to do, do hereby cancel the reservation over that portion of a primary-education reserve described in the First Schedule hereto, and do hereby reserve in lieu thereof the Crown lands of equal value described in the Second Schedule hereto.
