SCHEDULE.

ALL that portion of road in the Auckland Land District, Raglan County, known as Mary Street, commencing at its junction with River Road from Huntly to Ngaruawahia on

the west side of the Waikato River, in Block XV, Rangiriri Survey District, and proceeding thence generally in a westerly direction, and terminating at its junction with Alexandra Street in the said block and survey district; being a distance of 12½ chains, more or less. SCHEDULE.

ALL that portion of the Wanganui River Road (right bank) in the Taranaki Land District, Ohura County, commencing at the northernmost corner of Section 3, Block IV, Heao Survey District, and proceeding thence generally in a south-easterly direction adjoining or passing through the said Section 3 and Section 1 (scenic reserve), Block IV, Heao Survey District, and terminating at a point on the eastern boundary of the said Section 1 (scenic reserve), Block IV, Heao Survey District, being a distance of one mile seventeen chains, more or less. As the said portion of road is more particularly delineated on the plan marked P.W.D. 56432, deposited in the office of the Minister of Public Works at Wellington, in the Wellington Land District and thereon coloured red.

SCHEDULE.

ALL that road in the Auckland Land District, Raglan County, commencing at its junction with the Waitetuna-Aotea Road, and proceeding thence generally in a south-easterly direction, adjoining or passing through part Section 1 (forest reserve) and Sections 7 and 10, Block X, Karioi Survey District, and terminating at the southernmost corner of the said Section 10; being a distance of 3 miles 10 chains, more or less. As the same is more particularly delineated on the plan marked P.W.D. 56395, deposited in the office of the Minister of Public Works at Wellington, in the Wellington Land District, and thereon coloured red.
