4. No person shall kill or destroy any such imported game or native game, or shoot at or attempt to shoot at any such imported game or native game, with any automatic or autoloading gun, unless it is converted into a gun capable of carrying two cartridges only, or with any rifle or pea-rifle, swivel-gun or pump-gun, or shall use any gun other than a shoulder-gun; and no gun shall be used for the purpose aforesaid the bore of which is larger than the size known as No. 12 at the muzzle, nor shall any gun be used which

exceeds 10 lb. in weight.
