In pursuance and exercise of the power and authority conferred on him by section fifty-three of the Cook Islands Act, 1915, and of every other power and authority enabling him in that behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby amend, in the manner set out in the Schedule hereto, the regulations made under the said section fifty-three on the third day of November, one thousand nine hundred and twenty-two, and gazetted on the ninth day of the same month; and, with the like advice and consent, doth declare that the amendment hereby made shall come into operation on the date of the gazetting of this Order in Council.
