RESOLUTION MAKING SPECIAL RATE.

IN pursuance and in exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1913, and of all other powers (if any) it thereunto enabling, the Whakatane County Council hereby resolves as follows:—

That, for the purpose of providing for the payment of interest, sinking fund, and other charges on the Whakatane County Council Cattle-tick Dip Loan of £3,000, 1922, authorized to be raised by the said Council, under the above-mentioned Act, for the purpose of erecting seven cattle-tick dips and purchase of the necessary land, as authorized by section 203 of the Counties Act, 1920, the said Council hereby makes and levies a special rate of one-eighth of a penny (¼d.) in the pound sterling on the rateable value (on the basis of the unimproved value) of all rateable property in the Rangitaiki Plains Cattle-tick Dip Special Rating Area, viz.,—

All that area in the Auckland Land District, Whakatane County, bounded commencing at a point on the east bank of the mouth of the Tarawera River Diversion Block VI, Awa-ote-Atua S.D.; thence southerly along right bank of the Tarawera River to the southern corner of Section 6, Block IX, Rangitaiki Upper S.D. County Council Cattle-tick Dip Loan of £900, 1922, authorized to be raised by the said Council, under the above-mentioned Act, for the purpose of erecting two cattle-tick dips and purchase of the necessary land, as authorized by section 203 of the Counties Act, 1920, the said Council hereby makes and levies a special rate of one-third of a penny (⅓d.) in the pound sterling on the rateable value (on the basis of the unimproved value) of all rateable property in the Matata Cattle-tick Dip Special Rating Area, viz.,—
