M.D. 5635), showing the place where it is intended to erect such wharf, the area of foreshore and land below low-water mark to be occupied for such purpose, and the manner in which it is proposed to erect the wharf: And whereas it has been made to appear to the Governor-General in Council that the proposed work will not be or tend to the injury of navigation; and the said plans have, prior to the making of this Order in Council, been approved by the Governor-General in Council, without modification or addition: And whereas it is expedient that a license under the said Act, for the purpose

aforesaid, should be granted and issued to the company, on the terms and conditions set forth in the Schedule hereto: Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the power and authority vested in him by the said Act, and of all other powers and authority the solitor bin in that back and by and with the advice and consent of the Executive Council of the said Dominion, doth hereby approve of the purpose or object for which the said license is required by the company as aforesaid; and, in further pursuance and exercise of the said power and authority, and with the like advice and consent as aforesaid, doth hereby license and advice and consent as aforesaid, doth hereby incense and permit the company to use and occupy that part of the fore-shore and land below low-water mark which are particularly shown and delineated on the plans marked M.D. 5635 so deposited as aforesaid, for the purpose of constructing or erecting thereon a wharf, such license to be held and enjoyed by the company upon and subject to the terms and conditions set forth in the Schedule hereto.

SCHEDULE.

1. In these conditions the term "Minister" means the Minister of Marine as defined by the Shipping and Seamon Act, 1908, and includes any officer, person, or authority acting by or under the direction of such Minister. 2. The concessions and privileges conferred by this Order

in Council shall extend and apply only to the part of the foreshore and land below low-water mark necessary for the erection of such wharf which are shown on the plans marked M.D. 5635, and deposited in the office of the Marine Depart ment as aforesaid.

3. In consideration of the concessions and privileges granted this Order in Council, the company shall pay to the by this theorem of $\pounds 2$ 10s, and thereafter an annual sum of $\pounds 5$ in advance, payable on the first day of April in each year, the proportionate part of such rental in respect of the period from the date hereof until the 31st day of March following to be paid on the company being supplied with a copy of this O rder in Council.

4. His Majesty or the Governor-General, and all officers in the Government service acting in the execution of their duty. shall at all times have free ingress, passage, and egress into, through, over, and out of the said wharf without payment. 5. All persons shall at all reasonable times, and upon pay-

ment of the proper dues, have free and full liberty to use the said wharf, and all rights of ingress and egress thereon and therefrom.

6. The company shall maintain the above-mentioned wharf in good order and repair, and shall at all times exhibit there-from, and maintain at its own cost, suitable and necessary lights for the guidance of vessels; provided that no light shall be exhibited until after it has been approved of by the Minister.

7. Any person authorized by the Minister may, at all reasonable times, enter upon the said wharf and view the state of repair thereof; and upon the Minister leaving at or posting to the last known address of the company a notice in writing of any defect or want of repair in such wharf, requiring the company, within a reasonable time, to be therein prescribed, to make good the same, the company shall with all convenient speed cause such defect to be re-moved or such repairs to be made, as the case may be.

8. Nothing herein contained shall authorize the company to do or cause to be done anything repugnant to or incon-sistent with any law relating to the Customs, or with any regulation of the Minister of Customs, or with any provisions of the Harbours Act. 1908, or its amendments, or any regulations made thereunder, and that are now or may hereafter be in force.

9. The ballast of all vessels loading at the said wharf shall be taken away by the company and deposited above high-water mark, or at such place as may be approved of by the Minister or by any person appointed by the Minister for that purpose.

not assign, charge, or part with any such right, power, or privilege without the written consent of the Minister first obtained.

11. The said rights, powers, and privileges may be at any time resumed by the Governor-General, and the company may be required to remove the wharf at its own cost, without payment of any compensation whatever, on giving to the company three calendar months' previous notice in writing. Any such notice shall be sufficient if given by the Minister and delivered at or posted to the last known address of the

company in New Zealand. 12. The company shall be liable for any injury which the said wharf may cause any vessel or boat to sustain through any default or neglect on its part.

13. In case the company shall—
(1.) Commit or suffer a breach of the conditions hereinbefore set forth, or any of them

(2.) Cease to use or occupy the said wharf for a period of thirty days

(3.) Fail to pay the sums specified in clause 3 of these conditions; or

(4.) Be in any manner wound up or dissolved,-

then and in any of the said cases this Order in Council, and every license, right, power, or privilege thereby con-ferred, may be revoked and determined by the Governor-General in Council, without any notice to the company or other proceeding whatsoever; and publication in the New Zealand Gazette of an Order in Council containing such Zeriana variate of an order in council containing such revocation shall be sufficient notice to the company, and to all persons concerned or interested, that this Order in Council, and the license, rights, and privileges thereby granted and conferred, have been revoked and determined; and upon such revocation the Minister may cause the said wharf to be removed, and may recover the cost incurred by any such removal from the company.

14. The erection of the said wharf shall be sufficient evi-dence of the acceptance by the company of the terms and conditions of this Order in Council.
