PURSUANT to the powers vested in me by the Animals Protection and Game Act, 1921-22, I, John Rushworth, Viscount Jellicoe, Governor-General of the Dominion of New Zealand, do hereby declare that the areas described in the Schedule hereto shall be sanctuaries for the purposes in the Schedule hereto shall be sanctuaries for the purposes of the said Act, and that no imported or native game shall be taken or killed within the said areas except pursuant to an authority granted under section thirty-one or section thirty-two of the said Act; nor shall any person, except under such conditions as may from time to time be prescribed by the Minister, take any dog or firearm into such areas, or discharge any firearm or explosive in such areas, or discharge any firearm or explosive in such areas, or do anything likely to cause any imported game or native game to leave such areas.
