PAEROA BOROUGH COUNCIL.

RESOLUTION MAKING A SPECIAL RATE.

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1913, the Paeroa Borough Council hereby resolves as follows:—

That for the purpose of providing the interest and other charges on a loan of £1,000, authorized to be raised by the Paeroa Borough Council under the above-mentioned Act, for domain-improvements, the said Paeroa Borough Council hereby makes and levies a special rate of one-eighth of one penny ( $\frac{1}{8}$ d.) in the pound upon the unimproved value of all rateable property in the Borough of Paeroa; and that such special rate shall be an annually recurring rate during the currency of such loan, and be payable yearly on the 1st day of June in each and every year during the currency of such loan, being a period of  $36\frac{1}{2}$  years, or until the loan is fully paid off.

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1913, the Hamilton Borough Council hereby resolves as follows:—
