RESOLUTION MAKING AND LEVYING A Special Rate.-SPECIAL LOAN OF £375,000.

N pursuance and exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1913, and of all other powers (if any) it thereunto enabling, the Wanganui-Rangitikei Electric-power Board hereby resolves as follows :

That for the purpose of providing for the payment of in-terest, sinking fund, and all other charges on the Wanganui-Rangitikei Electric-power Board special loan of £375.000 authorized to be raised by the Wanganui-Rangitikei Electricpower Board under the above-mentioned Act for the following purposes :

(1.) To supply and distribute electric energy for the benefit of the Wanganui-Rangitikei Electric-power District, exclusive of the area comprised within the Borough of Wanganui, and for such purpose to de all or any of such matters and things which the Board is empowered to do by the Electric-power Boards Act, 1918, and its amendments, except such matters and things it is empowered to do by sections 88 and 90 thereof, and in particular, but without limiting in any way any of the aforesaid powers, to provide, erect, and construct a system of electrical distribution and reticulation, to purchase plant, land, easements, general equipment, and any existing electrical installations and plants, and to erect generating-stations, buildings, and offices within or without such district as dereinbefore defined, £355,000;
