And whereas, in the opinion of the Governor-General, it is expedient to exchange the Crown land described in the First Schedule hereto for the land of equal value described in the Second Schedule hereto, and the owner of the land described in the Second Schedule has agreed to such exchange:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in exercise of the aforesaid powers and authorities, doth hereby declare that it is his intention to grant in fee-simple the area of Crown land described in the First Schedule hereto in exchange for the fee-simple of the land described in the Second Schedule.

FIRST SCHEDULE.

DESCRIPTION OF LAND AUTHORIZED TO BE EXCHANGED.

ALL that area in the North Auckland Land District, containing by admeasurement 10 acres, more or less, being Section 16 (originally portion of Section 3), Block X, Mangakahia Survey District. As the same is delineated on the plan marked L. and S. 16/1124, deposited in the Head Office, Department of Lands and Survey, at Wellington, and thereon coloured brown.

SECOND SCHEDULE.

DESCRIPTION OF LAND TO BE OBTAINED IN EXCHANGE THEREFOR.

ALL those areas in the North Auckland Land District situated in Block X, Mangakahia Survey District, being part of Maungapohatu South No. 3 and part of Waiaruru No. 2 Blocks, containing by admeasurement 3 acres 1 rood and 1 acre 1 rood 22 perches respectively, more or less.
