Kiwitea County.—Town of Kimbolton.

(2.) *Deferred Payments*.—5 per cent. of the purchase-money and license fee (£1 ls.) on the fall of hammer; balance by equal annual instalments extending over nineteen years; interest payable half-yearly at the rate of 5 per cent. per annum on the unpaid purchase-money, but with the right to pay off at any time the whole or any part of the outstanding amount.

In either case, if the purchaser fails to make any of the prescribed payments by due date, whether of purchase-money or interest, the amount already paid shall be forfeited, and the contract for the sale of the land be null and void.

The valuation for improvements must be paid for on the fall of the hammer.
