"That the Council of the City of Dunedin hereby resolves that the provisions of section one hundred and seventeen of the Public Works Act, 1908, shall not apply to the following portions of the undermentioned streets in the City of Dunedin, viz: (1) Portion of the north-eastern side of English Avenue where the same abuts on part of Section 75, Block VI, Town District, Dunedin; (2) portion of the western side of Elgin Road where the same abuts on part of Section 75, Block VI, Town District, Dunedin; (3) portion of the southern side of Bowler Avenue where the same abuts on part of Section 75, Block VI Town the same abuts on part of Section 75, Block VI, Town District, Dunedin. As the said portions of the said English Avenue, Elgin Road, and Bowler Avenue respectively are more particularly shown by brown colour on the plan hereunto annexed ";

hereunto annexed "; subject to the condition that no building or part of a building shall at any time be erected on the north-eastern side of the portion of English Avenue, the western side of the portion of Elgin Road, and the southern side of the portion of Bowler Avenue (described in the Schedule hereto), within a distance of thirty-three feet from the centre-lines of the said portions of streets. of streets.
