TN pursuance and exercise of the powers conferred upon me by section three of the Electric-power Boards Act, 1918, and of every other power in anywise enabling me in that behalf, I, John Rushworth, Viscount Jellicoe, Governor-General of the Dominion of New Zealand, do hereby alter the boundaries of the Teviot Electric-power District, being an electric-power district duly constituted under the said Act by a Proclamation published in Gazette No. 68, of the twenty-second day of July, one thousand nine hundred and twenty, so as to include the areas described in the Schedule hereto.
