WHEREAS it is provided by section thirty-nine of the Finance Act, 1920, as amended by section forty-two of the Finance Act, 1924 (hereinafter referred to as "the said sections"), that the Governor-General in Council may, on the application of any Fire Board established under the Fire Brigades Act, 1908, extend the powers of that Board to borrow moneys in excess of the limits fixed by section six of the Fire Brigades Amendment Act, 1908:

And whereas application has been made by the Board of the Wanganui Fire District for increase in the borrowingpowers of the said Board, as provided by the said sections, and it is desirable to grant such request : Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of
