

Appointing the Time and Place for the First Meeting of the Waitemata Electric-power Board.

WHEREAS by section 4 of the Electric-power Boards Amendment Act, 1920, it is provided that the first meeting of the Board after the constitution of an electric-power district shall be held at such time and place as the Minister by notice in the *Gazette* appoints:

And whereas by a notice published in *Gazette* No. 81, of the 11th day of December, 1924, Friday, the 19th day of December, 1924, at 3 o'clock p.m., was fixed as the time and the Chamber of Commerce, Auckland, as the place, for holding the first meeting of the Waitemata Electric-power Board:

And whereas the first meeting of the said Board was not held at the time appointed, and it is considered expedient to appoint another date as the time for holding the first meeting:

Now, therefore, in pursuance and exercise of the powers conferred by the Electric-power Boards Amendment Act, 1920, and of all other powers in anywise enabling me in this behalf, I, Joseph Gordon Goates, Minister of Public Works, do hereby appoint Friday, the 16th day of January, 1925, at 2 o'clock p.m., as the time, and the Chamber of Commerce, Auckland, as the place, for holding the first meeting of the Waitemata Electric-power Board.
