southern boundary of Section 8, Block XIII, Kaitieke Survey District; thence to and along that boundary and the western boundary of Section 3, Block II, Manganui Survey District, and its production to the middle of the Ruatiti-Erua Road; thence south-westerly along the middle of that road to a point in line with the south-western boundary of Section 3, Block I, Manganui Survey District; thence to and along that boundary, part of the north-western boundary of Section 4, Block II, the south-western boundary of the last-mentioned section, and the south-western boundary of Sections 1 and 2. Block VI, and the production of the last-mentioned boundary to the middle of the Makino Road; thence south-westerly along the middle of that road to a point in line with the south-western boundary of Section 4, Block VI; thence along that boundary and the south-eastern boundary of the same section to the westernmost corner of Section 24, Block VII; thence along the south-western boundary of that section and its production to the middle of the Raetihi-Waimarino Road; thence along that road to a point in line with the south-western boundary of Section 24, Block XI, Manganui Survey District; thence to and along that boundary and its production to the middle of the Manganui-a-te-Ao River; thence along that river to a point in line with the eastern boundary of Section 18, Block VIII, Manganui Survey District; thence northerly to and along that boundary, across a public road, and along the eastern boundary of Section 13, Block VIII, Manganui, to its intersection with the middle of the Ngahuinga Stream; thence up that stream to its source, and along a right line to To Kahatu Trig. Station; thence along a right line to Pare-te-Taitonga Trig. Station, a right line to Ruapehu Trig. Station, a right line to Trig. Station aright line to Trig. Station 28 (Manukaiapu), a right line to Trig. Station 24 (Te Rotete), a right line to Trig. Station C (Anabitotara), a right line to Trig. Station A (Totem), and a right line to the middle of the Waiouru-Moawhango Road at its junction with the Waiouru Road: thence southerly along the middle with the Waiouru Road; thence southerly along the middle of that road to its intersection with the northern boundary of the Raketapauma No. 11 Block; thence westerly along that boundary and the northern boundaries of the Raketapauma Nos. 1g, 1a, and 3a 2 Blocks to the Turakina River; thence down the middle of that river to a point in line with the northern boundary of Section 4, Block II, Maungakaretu Survey District; thence to and along the northern boundaries of the said Section 4 and the northern boundaries of Sections 3, 2, and 1, Block II, the northern boundaries of Sec tions 4, 3, and 2, Otara Road, and Section 1, all of Block I, Maungakaretu Survey District, to and across the Owhahurs Road, to the northern boundary of Section 5, Block I, Maunga karetu Survey District; thence along that boundary and the northern boundaries of Sections 7 and 6, Block IV, Ngamatea Survey District, to the confluence of the Maketu and Waipapa Streams; thence along the northern boundary of Section 8, across a public road, and along the northern bound-ary of Section 1, Block IV, and its production to the middle of the Wangaehu River; thence down the middle of that river to its confluence with the Waokaramu Stream; thence up the middle of that stream and the north-eastern boundaries of Ohotu 6A No. 1B Block to its northernmost point; thence by the Karokio Stream and the western boundaries of Ohotu No. 6B Block to the north-eastern corner of Lot 2 of Ohotu No. 6B Block to the north-eastern corner of Lot 2 on plan 4978, deposited in the office of the District Land Registrar at Wellington; thence by the north-eastern and north-western boundaries of Lot 2 and the north-western and south-western boundaries of Lot 1, plan 4978 aforesaid, to the middle of the Auraki Stream; thence by the middle of the said Auraki Stream to the middle of the Mangawhero River; thence down middle of the said Mangawhero River; thence down middle of the southern boundary of Ohotu No. 9 Block; thence to and along that boundary and the southern boundary of Section 1, Block IX, Ngamatea Survey District, to the Aratawa Tric. Station: thence north-westerly District, to the Aratawa Trig. Station; thence north-westerly along the north-eastern boundary of Section 1, Block XII, Tauakira Survey District, to the middle of the Matakiwi-Ohotu Road; thence along the middle of that road to a point in line with the western boundary of Section 3, Block VIII; thence to and along the said western boundary, and the northern boundary of the said Section 3 to the middle of the Mangaetoroa Stream; thence up the middle of the said stream to and along the southern boundary of the Mairehau No. 2 Block; thence north-easterly along the south-eastern boundary of Marikau No. 1 Block to the middle of the Matihope Stream; thence down the middle of that stream and the Mangoihe Stream to the eastern boundary of Section 17, Block XV, Rarete Survey District; thence to and along that boundary and the northern boundary of the same section to the middle of the Matauriki Stream; thence up the middle of that stream and along the northern boundary of Section 11, Block XI, Rarete Survey District, to the north-eastern boundary of the Otaranoho Block; thence along the said north-eastern boundary and the northern and western boundaries of the said Otaranoho Block and the western

boundary of the Ohoutahi Block to the middle of the Wanganui River; thence up the middle of that river to the point of commencement; excluding the Boroughs of Ohakune and Raetihi and the Town District of Rangitaua.

Wanganui County.

All that area in the Wellington Land District bounded by a line commencing in the middle of the Wanganui River at a point opposite the north-western boundary of the Ohoutahi Block, being the south-western corner of the Waimarino County; thence by the southern boundaries of the Waimarino County hereinbefore described to the north-western corner of Section 7, Block IV, Ngamatea Survey District; thence southerly along the eastern boundary of the said Section 7, the eastern boundaries of Sections 6 and 9, Block VIII, Ngamatea Survey District, and the northern boundary of Pungataua Block and its production to the middle of the Koukoupo Road; thence south-westerly along the middle of the said road to a point in line with the south-western boundary of Section 71, Block XII, Ngamatea Survey District; thence to and along that boundary and the south-western boundary of Section 70, Block IX, Maungakaretu Survey District, and its production to the middle of the Hales Road; then south-westerly along that road to a point in line with the north-eastern boundary of Section 77, Block XVI, Ngamatea Survey District; thence to and along the north-eastern boundary of the said Section 77 and the southern boundary of Section 63, Block XIII, Maungakaretu Survey District, to the summit of the eastern watershed of the Wangaehu River; thence by lines from hill to hill along the summit of the eastern watershed aforesaid to a right line passing through the Okaiepe Trig. Station to a point in the middle of the Wangaehu River, distant about 18 chains due west of the western boundary of Block XIV, Mangawhero Survey District; thence down the middle of the said river to the sea-coast; thence north-westerly along the sea-coast to the middle of the Wanganui River, and up the middle of that river to the point of commencement: excluding that part of the Borough of Wanganui within the area herein specified.

ALL that area in the Wellington Land District bounded by a line commencing at the confluence of the Auraki Stream and the Mangawhero River, and proceeding in a north-easterly direction along the middle of the said Auraki Stream to a point opposite the south-western boundary line of Lot 1 on plan 4978, deposited in the office of the District Land Registrar at Wellington, being part of Ohotu Subdivision 4B No. 2; thence to and along the south-western and northern boundaries of the said Lot 1 and the northern boundary of Lot 2 on plan 4978 aforesaid, to the western boundary of Ohotu Subdivision 6B; thence again towards the north-east generally by the north-western boundary of the said Ohotu 6B; the western and northern boundaries of Ohotu Subdivision 6A No. 1B, and the Waokaramu Stream to the middle of Field's No. 1B, and the Wackaramu Stream to the middle of Field's Track; thence westerly and southerly by the middle of Field's Track to its junction with the stock road intersecting Parapara 2B I Block and forming the western boundary of Parapara 2B Block and Sections 12 and 13 (Taonui Block), Block XV, Ngamatea Survey District, Sections 2 and 3 (Taonui Block), Block III, Mangawhere Survey District; Sections 1 2 2 and 4 (Heep Block), Block VII Mangawhere (1aonul Block), Block III, Mangawhero Survey District; Sections 1, 2, 3, and 4 (Heao Block), Block VII, Mangawhero Survey District, Sections 5, 6, and 7 (Heao Block), Block X, Mangawhero Survey District; thence by the north-western boundary of Section 8 (Heao Block), Block X aforesaid; the south-western boundaries of Sections 18, Block X, and 19 and 20, Block IX, Mangawhero Survey District, to the stream forming the northern and eastern boundaries of the Pohuehue Block and part of the eastern boundary of the Piko Piko No. 3 Block; thence by that stream to the northern boundary of the Te Maire Block; thence along the northern and western boundaries of the Te Maire Block and the eastern boundary of Block XVI, Waipakura Survey District; thence by the eastern boundary of Section 305, Block I, Wangashu Survey District, to the south-eastern corner of the said Section 305; thence north-westerly along the northern boundaries of Sections 304, Block I, Wangaehu Survey District, Sections 329, 331, 332, 333, 334, 335, and 336, Block IV, Ikitaia Survey District; thence by the northern and western boundaries of Sections 339, 340, 341, 351, and 352, Block III, Ikitaia Survey District; thence by the northern boundaries of Section 361, the northern and western boundaries of Section 360, the western boundary of Section 295, and the northern boundary of Section 293, Block III, Ikitaia Survey District; thence along the northern and western boundaries of Section 292, Block II, Ikitaia Survey District, to the stream intersecting Sections 120, 119, 118, and 117; thence by that stream to
