Crown Land set aside as a Provisional State Forest.

CHARLES FERGUSSON, Governor-General. [L.S.] A PROCLAMATION.

BY virtue and in exercise of the powers and authorities conferred upon me by section eighteen of the Forests Act, 1921-22, I, General Sir Charles Fergusson, Baronet, Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, do hereby set apart the Crown land described in the Schedule heretors a purprised State forest

described in the Schedule hereto as a provisional State forest.

SCHEDULE.

WESTLAND LAND DISTRICT.--WESTLAND FOREST-CONSERVA-TION REGION.

Provisional State Forest No. 1723.

ALL that area in the Westland Land District, containing by admeasurement 466 acres 2 roods 30 perches, more or less, being Section 2807, Block V, Waiho Survey District. As the same is more particularly delineated on plan No. 139/1, de-posited in the Head Office of the State Forest Service at Wel-lington and theorem bondered and lington, and thereon bordered red.
