A PROCLAMATION.

IN pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1908, and the Public Works Amendment Act, 1909, and of every other power and authority in anywise enabling me in this behalf, I, Sir Charles Fergusson, Baronet, Governor-General of the Dominion of New Zealand, do hereby declare the land described in the Schedule hereto to be Crown land subject to the Land Act, 1924.

SCHEDULE.

APPROXIMATE area of the piece of land declared to be Crown land: 10 acres 0 roods 8 perches.
Being portion of Section 32 (Waitohi Valley).

Situated in Block XV, Linkwater Survey District.

In the Marlborough Land District; as the same is more particularly delineated on the plan marked P.W.D. 61647, deposited in the office of the Minister of Public Works at Wellington, in the Wellington Land District, and thereon edged red.

IN pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1908, and of every other power and authority in anywise enabling me in this behalf, I, Sir Charles Fergusson, Baronet, Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the land described in the Schedule hereto is hereby taken for the development of water-power (Lake Coleridge scheme); and I do also declare that this Proclamation shall take effect on and after the second day of January, one thousand nine hundred and twenty-five.
