W HEREAS by section one hundred and thirty-two of VV the Native Land Act, 1909, it is provided that, for the purpose of enabling any scheme of consolidation of the interests of owners of Native land into suitable areas to be prepared and carried into effect, the Governor-General may, by Order in Council, prohibit for a period not exceeding twelve months any alienation of Native land in respect of which application has been made by a Native Minister to the Court for the preparation of such a scheme:

And whereas it is provided by section eight of the Native Land Amendment and Native Land Claims Adjustment Act,

1923, that any such Order in Council may be extended from

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the power and authority hereinbefore mentioned, and acting by and with the advice and consent of the Executive Council, doth hereby extend for a period of twelve months the Order in Council prohibiting alienation dated the twenty-ninth day of September, one thousand nine hundred and twenty-four, and published in the New Zealand Gazette of the second day of October, one thousand nine hundred and twenty-four, so far as it affects the Native land specified in the Schedule hereto.

New Zealand, acting by and with the advice and consent of the
