Redefining Boundaries of the Borough of Mount Eden, the County of Eden, and Mount Roskill Road District.

URSUANT to the provisions of section 141 of the Municipal Corporations Act, 1920, the boundaries of the Borough of Mount Eden are hereby defined as set out in the First Schedule hereto, the boundaries of the said borough having been altered by Order in Council dated the 21st day of September, 1925, made under the Municipal Corporations Act, 1920, and published in Gazette No. 65 of the 24th day of September, 1925.

And also in pursuance of the provisions of the said section 141 of the Municipal Corporations Act, 1920, the boundaries of the County of Eden affected by the said Order in Council dated the 21st day of September, 1925, are hereby defined as set out in the Second Schedule hereto.

And in further pursuance of the provisions of the said section 141 of the Municipal Corporations Act, 1920, the boundaries of the Mount Roskill Road District affected by the said Order in Council dated the 21st day of September, 1925, are hereby defined as set out in the Third Schedule hereto.

Allotment 91, Section 10 aforesaid; thence by the northern boundary of Allotment 91 aforesaid to and across Lovers' Lane, to and by the northern boundary of Allotment 116, Section 10 aforesaid, to a point distant 339.4 links from the eastern side of Dominion Road; thence by the eastern and part of the northern boundaries of part Allotment 115, Section 10 aforesaid, to the south-eastern corner of Lot 14 of Allotment 115 aforesaid; thence by the eastern boundaries of Lots 14 and 13 of Allotment 115 aforesaid and the eastern boundaries of parts of Allotment 115 aforesaid and by the eastern and part of the northern boundaries of Lot 12 of Allotment 115 aforesaid to the south-eastern corner of Lot 3 of Allotment 115 aforesaid; thence by the eastern boundaries of Lots 3 and 1 of Allotment 115 aforesaid to a point on the southern side of the Boundary Road, distant 200 links from Dominion Road, the aforesaid subdivisions of Allotment 115, Section 10, Suburbs of Auckland, being more particularly shown on deeds registration plan 550 deposited in the office of the District Land Registrar at Auckland; thence by the southern side of Boundary Road aforesaid to Dominion Road; thence by a right line across Dominion Road to the north-eastern corner of Allotment 125, Section 10 aforesaid; thence by the northern boundary of Allotment 125 aforesaid to the eastern boundary of Allotment 46, Parish of Titirangi; to the eastern boundary of Allotment 46, Parish of Titirang;; thence by the eastern boundary aforesaid and by the eastern boundaries of Allotments 178, 146, 145, 144, 143 to and across Balmoral Road to and by the eastern boundaries of Allotments 142, 141, 140, 139, 138, and part 137, all of Section 10, Suburbs of Auckland, to and by the eastern side of Cricket Avenue to and across Raleigh Street; thence by the northern side of Raleigh Street, being the original southern boundary of Allotment 12, Section 10, Suburbs of Auckland, to and across Kowhai Street, and again by the northern side of Raleigh Street and by the original southern boundary of Allotment 12 aforesaid to a point being the intersection of the preduction of the the production of the western boundary of a subdivision of part Allotment 11, Section 10 aforesaid, shown on deeds registration plan 47 (blue) deposited in the office of the District Land Registrar at Auckland, with the southern boundary of Allotment 12, Section 10 aforesaid; thence by a right line to the south-western corner of subdivision of part Allotment 11, Section 10 hereinbefore mentioned; thence by the western boundary of aforesaid subdivision to a line distant 235 links from and parallel with New North Road; thence by that line to Dominion Road; thence by a right line across Dominion Road to the westernmost corner of Allotment 2r, Section 10, Suburbs of Auckland; thence by the south-western boundary of Allotment 2r aforesaid to its southernmost corner, the point of commencement.

ALL that area in the North Auckland Land District bounded towards the north generally by Waitemata Harbour from the Whau River to the Tamaki River; thence towards the east generally by the Tamaki River and the Otahuhu Creek to Portage Road; thence towards the south by Portage Road to Manukau Harbour; thence towards the west and again towards the south by Manukau Harbour to the Borough of Onehunga; thence by that borough and again by Manukau Harbour to the western side of Portage Road at Karaka Bay; thence towards the west by the western side of Portage Road to the Town District of New Lynn; thence by the Town District of New Lynn; thence by the caross and by the Whau River to Waitemata Harbour, the place of commencement: excluding therefrom the City of Auckland, the boroughs of Newmarket, Mount Albert, Mount Eden, and Avondale, and the Town District of Ellerslie.

THIRD SCHEDULE.

BOUNDARIES OF MOUNT ROSKILL ROAD DISTRICT.

ALL that area in the North Auckland Land District bounded, commencing at the southern extremity of the eastern boundary of Allotment 75, Parish of Titirangi, on the Manukau Harbour, by the Borough of Avondale, as described in New Zealand Gazette, 1924, page 2072, to and by the Borough of Mount Albert as described in New Zealand Gazette, 1924, page 2072, to the Borough of Mount Eden hereinbefore described; thence by the southern boundary of the Borough of Mount Eden aforesaid to and by the southern boundary of the City of Auckland as described in New Zealand Gazette, 1921, page 770, to the Auckland-Onehunga Road; thence by a right line across the said road to and by the One Tree Hill Road District as described in New Zealand Gazette, 1917, page 2976, to and by the western boundary of the Borough of Onehunga as described in New Zealand Gazette, 1917, page 2976, to the Manukau Harbour; thence by the Manukau Harbour to the point of commencement.
