RESOLUTION MAKING SPECIAL RATE.

IN pursuance and exercise of the powers vested in it in that behalf by the Local Bodies Loans Act, 1913, and of all other powers (if any) it thereunto enabling, the Waikato County Council hereby resolves as follows:—

That, for the purpose of providing the payment of interest, sinking fund, and other charges on the Waikato County Kainui Special-rating District No. 2 Loan of £1,500, 1925, authorized to be raised by the Waikato County Council under the above-mentioned Act, for the purpose of constructing and metalling roads in the Kainui Special-rating District No. 2, the said Council hereby makes and levies a special rate of one (1) penny in the pound sterling on the rateable value (on the basis of the capital value) of all rateable property in the Kainui Special-rating District No. 2 in the County of Waikato, being all that area in the County of Waikato, being part of Blocks IV and VIII of the Newcastle Survey District, and Blocks I and V of the Komakorau Survey District.
