IN pursuance and exercise of the powers conferred by the Public Works Act, 1908, and of all other powers in anywise enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby approve of the following resolution passed by the Lower Hutt Borough Council on the twenty-eighth day of October, one thousand nine hundred and twenty-

THE northern side of all that street situated in the Wellington Land District, Borough of Lower Hutt, known as Donald
