Amending Regulations for the Carriage of Deck Cargo

WHEREAS by Warrant dated the 26th day of April, 1911, and the 13th day of May, 1923, and published in the New Zealand Gazette No. 36, of the 4th day of May, 1911, and No. 42, of the 22nd day of May, 1913, respectively, regulations were made governing the issue of licenses for the carriage of cargo and live-stock on the decks of vessels:

And whereas it is desirable to make an additional regular.

And whereas it is desirable to make an additional regula-tion as hereinafter prescribed:

Now, therefore, I, George James Anderson, Minister of Marine, in pursuance and exercise of the power and authority conferred upon me by section 223 of the Shipping and Seamen Act, 1908, and of all other powers and authorities enabling me in that behalf, do hereby make the following additional regulation:—

"30 (b.) On scows the whole or part of whose deck cargo

"30 (6.) On scows the whole or part of whose deck cargo is petroleum, such petroleum may be stowed from rail to rail with a flat and even surface fore and aft and athwartship; and it shall be properly secured to the satisfaction of the Superintendent. Such lines as he may require for the protection of life shall be properly fitted and secured and planking placed to enable persons to pass to and fro over the petroleum."
