Altering Boundaries of Hawera and Eltham Counties, and including Area in Omona Riding, Eltham County.

[L.S.] CHARLES FERGUSSON, Governor-General. A PROCLAMATION.

WHEREAS it is provided by subsection two of section fourteen of the Counties Act, 1920, that the boundaries of any one or more counties may be altered in accordance with a resolution proposing the alteration passed by the Council of each of such counties in which the Counties Act is in force :

And whereas a resolution was passed by the Hawera County Council on the seventh day of November, one thousand nine hundred and twenty-five :

And whereas a similar resolution was passed by the Eltham County Council on the twentieth day of November, one thousand nine hundred and twenty-five, praying for the alteration of the boundaries of the Hawera and Eltham Counties in the manner described in the said resolutions and in the First Schedule hereto:

And whereas it is expedient to make such alteration in accordance with the said resolutions, and that the area to be added to the Eltham County should be included in the Omona Riding of that county :

Now, therefore, in pursuance and exercise of the power and authority conferred on me by the said Act, I, General Sir Charles Fergusson, Baronet, Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the area described in the First Schedule hereto, being now part of the Hawera County, shall be added to and form part of the Eltham County; that the boundaries of the Hawera and Eltham Counties as so altered shall be those set forth under the respective headings in the Second Schedule hereto : that the area added as aforesaid to the Eltham County shall be included in the Omona Riding of the said county; and that the boundaries of that riding shall be those set forth in the Third Schedule hereto :

And I do also proclaim and declare that this Proclamation shall take effect on the first day of April, one thousand nine hundred and twenty-six.

FIRST SCHEDULE.

Area excluded from Hawera County and included in Eltham County.

ALL that area in the Taranaki Land District bounded towards the north-east by a line along the middle of Rawhitiroa Road from the junction with Lower Moeawatea Road to Koane Road; thence towards the east by a line along the middle of Koane Road to a point opposite the northern corner of Section 4, Block I, Kapara Survey District; thence to and along that section to Section 10, Block IV, Opaku Survey District; thence towards the south by Sections 10 and 3, Block IV aforesaid, to Lower Moeawatea Road; and thence towards the west along the middle of the Lower Moeawatea Road to its junction with the Rawhitiroa Road, the place of commencement.

SECOND SCHEDULE.

HAWERA COUNTY.

ALL that area in the Taranaki Land District bounded by a line commencing at the intersection of Skeet and Palmer Roads, Kaupokonui Survey District; thence by a line along the middle of Skeet Road to the Waingongoro River; thence along the middle of the Waingongoro River to Onewhaia Road, along the middle of that road to Mountain Road; thence by a right line to the southern boundary of Section 12, Block II, Hawera Survey District; thence along the southern boundary of that section to the middle of the Mangapous Stream; along that stream to the southern boundary of Section 20, Block II, Hawera Survey District; thence along the middle of Fraser and Tiromoana Roads to the southern boundary to the middle of Fraser Road; thence along the middle of Fraser and Tiromoana Roads to the southern boundary of Subdivision 9; thence north-easterly along the south-eastern boundary of Section 4, Block III, Hawera Survey District; thence north-westerly along that boundary to the middle of the Ararata Stream; thence along the middle of the Ararata Stream to the junction of the Rotokare and Makino Roads; thence along the middle of the Rotokare Road to the northern boundary of Section 13, Block XV, Ngaire Survey District; thence by the northern boundaries of Sections 13, 14, and 25
