

to the westernmost corner of the Tutaeariari No. 1 Block; thence along the north-western boundaries of Subdivisions 1, 3, 5, 7, and 9, Tutaeariari No. 1 Block to the Makino Stream; thence by that stream to the north-eastern boundary of Subdivision 6, Tutaeariari No. 1 Block; thence by that north-eastern boundary and its production to Roimata Trig. Station; thence by a right line to Waipuna Trig. Station; thence along the northern boundaries of Sections 2 and 4, Block XIV, Omona Survey District, to the Whenuakura Valley Road; thence along the middle of that road and the Epiro Road to the eastern boundary of Section 4, Block XV, Omona Survey District; thence by the eastern boundaries of Sections 4 and 9, Block XV aforesaid, to the Lower Moeawatea Road; thence along the middle of the Lower Moeawatea Road to a point opposite the north-eastern corner of Section 2, Block IV, Opaku Survey District; thence towards the south-east generally to and by the said Section 2, Section 1, Block IV, aforesaid, and Section 2, Block III, Opaku Survey District, to Whenuakura Valley Road; along the eastern side of that road to a point in line with the southern boundary of Section 1, Block III aforesaid; thence to and along the southern boundary of that section, by part of the north-eastern and the south-western boundaries of Section 6, Block II, Opaku Survey District, and the last-mentioned boundary produced to the middle of the Patea River, by a line along the middle of that river to the south-western boundary of Rotorangi Block; thence by a right line to Tarere Trig. Station, and in a right line to the source of the Poroporo Stream, by a line along the middle of that stream to the Ingahape Stream, along the middle of the Ingahape Stream to the Manawapou River, and along the middle of the Manawapou River to the sea; thence towards the south-west by the sea to the middle of Inaha Road; thence towards the west by a line along the middle of Inaha Road to its junction with Normanby Road; thence to and along the eastern boundary of Block III, Waimate Survey District, to Section 74, Block III aforesaid, by that section to Palmer Road; and thence by a line along the middle of Palmer Road to its junction with Skeet Road, the place of commencement; excluding therefrom the Borough of Hawera.

#### ELTHAM COUNTY.

All that area in the Taranaki Land District bounded by a line from the summit of Mount Egmont to the north-eastern corner of Section 11, Block VI, Kaupokonui Survey District; thence southerly along the eastern boundaries of Sections 11, 13, and 16, Block VI aforesaid, to Opunake Road; thence along the middle of that road to the eastern boundary of Section 1, Block VI aforesaid; thence southerly along that boundary to the south-eastern corner of the said Section 1; thence easterly along the southern boundaries of Sections 2 and 3, Block VI aforesaid, to Rowan Road; thence to and along the middle of that road to the southern boundary of Section 12, Block VII, Kaupokonui Survey District; thence easterly along the southern boundaries of Sections 12, 13, 14, 15, 18, and 37, Block VII aforesaid, to Palmer Road; thence to and along the middle of Palmer Road to the southern boundary of Section 25, Block VIII, Kaupokonui Survey District; thence along the southern boundary of Section 25, Block VIII aforesaid, to Duthie Road, across Duthie Road, and along the southern and western boundaries of Section 26 to the south-western corner of Section 27, Block VIII aforesaid; thence easterly along the southern boundary of said Section 27 to Hastings Road; thence to and along the middle of Hastings Road to Finnerty Road; thence easterly along the middle of Finnerty Road to the Wangongoro Stream; thence up the middle of that stream to Cornwall Road; thence along the middle of Cornwall Road and the northern boundary of Block X, Ngaire Survey District, to Karepo Road; thence along the middle of Karepo Road to Oru Road, and along the middle of Oru Road to the north-western boundary of Section 35; thence along that boundary and the north-eastern boundaries of 35, 36, and 41, Block XI, Ngaire Survey District, to the north-western boundary of Subdivision 13, Pukengahu Block; thence north-easterly along that boundary to a point due west of Trig. Station B, Rahui; thence due east to Pukengahu Road, and along the middle of that road to the north-western boundary-line of Subdivision 15, Pukengahu Block; thence north-easterly along the said north-western boundary to the southern boundary of the northern part of said Subdivision 15, containing 23 acres 1 rood 8 perches; thence by the southern boundary of the said northern part to the eastern boundary of the said Subdivision 15; thence by that boundary to Trig. Station B, Rahui; thence easterly along the southern boundary of Section 4 and the southern and eastern boundaries of Section 5, Block VIII, Ngaire Survey District, to the north-western corner of Section 11, Block VIII aforesaid; thence by the northern boundary of said Section 11 to the middle of the Patea River; thence down the middle of the Patea River to the southern boundary of Subsection 7, Subdivision 1, Matemateonga Block; thence along the southern and eastern boundaries of Subsection 7

and the south-eastern boundaries of Subsection 6 of Subdivision 1, Matemateonga Block aforesaid, to the south-western corner of Section 9s, Tawhiwhi Settlement; thence along the south-eastern boundaries of Sections 9s and 5s, Tawhiwhi Settlement, to the easternmost corner of the last-mentioned section; thence along the southern boundaries generally of Section 8, Block II, Omona Survey District, and part of the south-western boundary of Section 14, Block VII, Omona Survey District, to the Waitiri Road; thence southerly along that road to the south-western corner of Section 11, Block VII aforesaid; thence easterly along the northern boundaries of Sections 1, 4, and 21 (quarry reserve), Block VII, and Sections 1, 4, and 3, Block VIII, Omona Survey District, to the middle of the Moeawatea Road; thence southerly generally along the middle of the Moeawatea Road to Koane Road; thence along the middle of Koane Road to the eastern boundary of Section 5, Block XVI, Omona Survey District; thence along the eastern and southern boundaries of Section 5 aforesaid to the Lower Moeawatea Road; thence to and along the middle of that road to a point opposite the southernmost corner of Section 3, Block XVI, Omona Survey District; thence to and along the south-western and western boundaries of that section to Epero Road; thence along the middle of the Epero and Whenuakura Valley Roads to a point opposite the north-eastern corner of Section 4, Block XIV, Omona Survey District; thence along the northern boundaries of that section, Section 2, Block XIV aforesaid, Section 4, Block XIII, and the production of the northern boundary of the last-mentioned section across the Patea River, and along the northern boundary of Section 6, Block XIII aforesaid, to Roimata Trig. Station; thence by a right line to the easternmost corner of Subsection 6 of Tutaeariari No. 1 Block, and by that subsection to the Makino Stream; thence up the middle of that stream to its intersection with the north-western boundary of Subsection 9, Tutaeariari No. 1 Block; thence along the north-western boundary of that block to Section 25, Block XV, Ngaire Survey District, along the north-eastern and western boundaries of that section to the south-eastern corner of Subdivision 1 (northern part) of Section 14, Block XV aforesaid; thence along the southern boundary of the said Subdivision 1, Section 14 aforesaid, and the western boundary of the said Section 14 to the south-eastern corner of Section 12; thence along the southern boundary of Section 12, Block XV aforesaid, to the Rotokare Road; thence by a line along the middle of that road to the Ararata Stream at the junction of the Rotokare and Makino Roads, and by a line along the middle of that stream to the north-eastern boundary of Block II, Hawera Survey District; thence by Block III, Hawera Survey District, to the south-eastern boundary of Subdivision 9, Section 4, of Block II aforesaid; thence by the south-eastern boundary of that subdivision and its production to the middle of Tiro-moana Road, and by a line along the middle of that road to Fraser Road, by a line along the middle of Fraser Road to a point in line with the northern boundary of Section 21, Block II aforesaid; thence to and along the northern boundaries of Sections 21 and 13 to Mountain Road; thence by a right line to the easternmost corner of Section 326, Block I, Hawera Survey District, and along the north-eastern boundaries of Sections 326, 325, and 324 to Onewhaia Road; thence by a line along the middle of that road to the Waingongoro River, and by a line along the middle of that river to Skeet Road; thence by a line along the middle of Skeet Road to its junction with Palmer Road; thence northerly by a line along the middle of Palmer Road to the north-eastern corner of Block XV, Kaupokonui Survey District; thence westerly along the northern boundaries of Blocks XV and XIV, Kaupokonui Survey District, to the middle of Auroa Road; and thence again northerly by a line along the middle of Auroa Road to the southern boundary of Mount Egmont Forest Reserve; and thence by a right line to the summit of Mount Egmont, the place of commencement; and excepting therefrom the Borough of Eltham.

#### THIRD SCHEDULE.

##### OMONA RIDING, ELTHAM COUNTY.

All that area in the Eltham County bounded on the north, east, and south by the county boundary, hereinbefore described, and on the west by the Patea River.
