WHEREAS, in pursuance of section one hundred and thirty-two of the Municipal Corporations Act, 1920, a petition was presented to the Governor-General praying that a certain area should be excluded from the Borough of Otaki and included in the County of Horowhenua:

And whereas a Commission appointed under the said section held inquiries, and recommended certain alterations of the said area:

And whereas it is deemed expedient to make such alteration of boundaries of the said borough, and to declare to what riding of the said county such area shall be added:

Now, therefore, in pursuance and exercise of the powers and authorities vested in him by the Municipal Corporations Act, 1920, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby declare that as on and from the first day of April, one thousand nine hundred and twenty-six, the area described in the Schedule hereto shall be excluded from the Borough of Otaki and included in the County of Horowhenua; and, with the like advice and consent, doth hereby further declare that as on and from the aforesaid date the area included as aforesaid in the County of Horowhenua shall be added to and form part of the Otaki Riding of that county.

SCHEDULE.

AREA EXCLUDED FROM BOROUGH OF OTAKI.
