CHARLES FERGUSSON, Governor-General. A PROCLAMATION.

IN pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1908, and of every other power and authority in anywise enabling me in this behalf, I, General Sir Charles Fergusson, Baronet, Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that the additional land described in the Schedule heroto is hereby taken for the purposes of a road; and I do also declare that this Proclamation shall take effect on and after the sixth day of April, one thousand nine hundred and twenty-six.
