ERRATA.—In the Order in Council dated the 20th day of February, 1924, and published in the New Zealand Gazette No. 13, page 589, of the 28th day of February, 1924, declaring Taumatatotara Block Access Road, in the Kawhia County, to be a county road, read "county road" in lieu of "Government road" in the ninth line of the said Order in Council. I N pursuance and exercise of the powers conferred by section twelve of the Land Act, 1924, I, General Sir Charles Fergusson, Baronet, Governor-General of the Dominion of New Zealand, do hereby proclaim as a road the land in Kuriwao Survey District described in the First Schedule hereto; and also do hereby proclaim as closed the road described in the Second Schedule hereto.

#### FIRST SCHEDULE.

LAND PROCLAIMED AS A ROAD.

APPROXIMATE area of the piece of land proclaimed as a road: 1 acre 0 roods 4 perches.

Portion of Section 4; coloured red.

#### SECOND SCHEDULE.

ROAD CLOSED.
