Now, therefore, in pursuance of section 33 of the said Act, I do hereby direct that on and after the 21st day of June, 1926, the sale of the said goods within the Borough of Dannevirke shall be and is hereby prohibited as follows—on Monday, Tues-day, Thursday, and Friday after the hour of 6 p.m., and on Saturday after the hour of 9.30 p.m., with the following ex-ceptions—(1) on the Thursday immediately preceding Good Friday the sale of the said goods is prohibited after the hour of 10.30 pm = (2) on the working day, their first preceden (1) That the same of the same goods is product after the norm of 10.30 p.m.; (2) on the working-day that first precedes Christmas Day and on the working-day that first precedes New Year's Day the sale of the said goods is not prohibited.
