WHEREAS by section three hundred and sixty-three of the Native Land Act, 1909, it is enacted that any Order in Council made under that section may at any time be varied or revoked:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the power and authority hereinbefore mentioned, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby revoke the Order in Council referred to in Part I of the Schedule hereto, but only in so far as it affects the land mentioned in Part II of the said Schedule.

WHEREAS by section one hundred and thirty-two of the Native Land Act, 1909, it is enacted that any Order in Council made thereunder may be at any time varied or revoked:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the power and authority hereinbefore mentioned, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby vary an Order in Council

dated the twenty-ninth day of September, one thousand nine hundred and twenty-four, published in the *New Zealand Gazette* of the second day of October, one thousand nine hundred and twenty-four, as extended by Order in Council dated the thirty-first day of August, one thousand nine hundred and twenty-five, and published in the *New Zealand Gazette* of the third day of September, one thousand nine hundred and twenty-five, and made under the said section one hundred and thirty-two, regarding the Ahomatariki 2B and other blocks set out in the Schedule thereto by excluding and excepting from prohibition of alienation the lands set out in the Schedule hereto.
