HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

7 HEREAS by section eleven of the Finance Act, 1921, W Indicates by section eleven of the Finance Act, 1921, and its amendments, it is provided that, notwith-standing anything to the contrary in any Act or in any rule of law, where a local authority or public body has been autho-rized before the passing of the said Act, or is thereafter autho-rized, to borrow money, whether pursuant to a poll of rate-payers or otherwise howsoever, whether the rate of interest or the term of years of the loop was or was not specified or or the term of years of the loan was or was not specified or determined, and such money or any part thereof has not been borrowed, the local authority may, with the precedent consent of the Minister of Finance, borrow such money, or such amount thereof as has not been borrowed, at such rate of interest, or for such term, as may be prescribed by the Governor-General by Order in Council : And whereas the Taihape Borough Council has been autho-rized to borrow the sum of five thousand pounds for the pur-

chase of land and erection of abattoirs, and is now desirous of borrowing an additional sum of five hundred pounds under the authority of section eighteen of the Local Bodies' Loans Act, 1913, for the purpose of completing the undertaking :
